RESOLUTION COUNCIL SERIES NO. C-1878

A RESOLUTION REESTABLISHING THE LEGAL MAXIMUM MILLAGE RATES FOR THE YEAR 2006

WHEREAS, in accordance with the provisions of Article VII, Section 23 (B) and (C) of the 1974 Louisiana Constitution and R.S.47:1705(B)(1)and (2), a taxing authority is required to adopt Resolutions No. 1 and No. 2 to increase its millage rate(s) after reassessment but not in excess of the prior years maximum authorized millage rate(s).

RESOLUTION NO. 2

NOW, THEREFORE, BE IT RESOLVED BY THE ST. TAMMANY PARISH COUNCIL, in a public hearing held on September 7, 2006, which hearing was conducted in accordance with the open meetings law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the taxing authority voted to increase the millage rate(s), but not in excess of the prior year's maximum rate(s), on all taxable property shown on the official assessment roll of the year 2006, and when collected, the revenues from said taxes shall be used only for the specific purposes for which the said taxes have been levied.
