WHEREAS, the St. Tammany Parish Government ("Parish") has determined that it is in the public interest to enter into this Non-exclusive Servitude/Right of Way Agreement; and

WHEREAS, it is the desire of St. Tammany Parish Government to grant a servitude on this property to Washington St. Tammany Electric Cooperative for the purpose of accommodating the need for more power lines in this Parish; and

WHEREAS, the legal description is as follows:

TOWNSHIP 8 SOUTH - RANGE 13 EAST

A CERTAIN PORTION OF GROUND LOCATED IN THE SW/4 OF SECTION 4 AND THE SE/4 OF SECTION 5, T8S - R13E, GREENSBURG LAND DISTRICT, ST. TAMMANY PARISH, LOUISIANA CONTAINING 1.82 ACRES, MORE OR LESS. SAID 1.82 ACRE PARCEL BEING MORE FULLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT BEING THE INTERSECTION OF SECTIONS 4, 5, 8 & 9, T8S-R13E. THENCE, N 89°45'00" W FOR A DISTANCE OF 237.29 FEET TO THE POINT OF BEGINNING; THENCE, FROM SAID POINT CONTINUE N 89°45'00" W A DISTANCE OF 64.21 FEET; THENCE, N 31°00'12" E FOR A DISTANCE OF 1456.57 FEET TO A POINT; THENCE, S 58°59'48" E FOR A DISTANCE OF 55.00 FEET TO A POINT; THENCE, S 31°00'12" W FOR A DISTANCE OF 1424.56 FEET TO A POINT BEING THE POINT OF BEGINNING. CONTAINING 1.82 ACRES OF LAND, MORE OR LESS.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that it authorizes the Office of the Parish President to enter into a Non-exclusive Servitude/Right of Way Agreement with Washington St. Tammany Electric Cooperative for all that certain parcel of land, commonly referred to as SECTIONS 4 and 5, T8S, R13E along Highway 434, St. Tammany Parish, Louisiana.

That pursuant to all applicable provisions of law, the Office of the Parish President is directed and authorized to do whatever is necessary to enter into the Servitude/Right of Way Agreement the Property.

That the Office of the Parish President is authorized to exercise its discretion in granting a servitude on this property, together with all agreements and all transactions necessary to carry out the intent of this Ordinance.
