ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACCEPT A LATERAL DRAINAGE EASEMENT FROM GULF SOUTH EQUITIES, IN SECTION 39, T8S, R14E FOR INCLUSION INTO THE PARISH MAINTENANCE SYSTEM, WARD 9, DISTRICT 11

WHEREAS, the lateral drainage easement on the two properties described herein, by Gulf South Equities, is accepted and same shall be incorporated into the St. Tammany Parish Selective Maintenance System Inventory; and

WHEREAS, the Parish President and/or CAO is hereby authorized to execute any and all documents necessary in connection with said acceptance of the drainage easement; and

WHEREAS, the Department of Public Works is directed to provide the appropriate maintenance thereto; and

WHEREAS, the legal descriptions are as follows:

## PARCEL No. 1:

A certain piece or portion of land, being situated in Headright 39, Township 8 South, Range 14 East, St. Tammany Parish, Louisiana, being described according to a survey made by Ivan M. Borgen, C.E., dated September 18, 1978, being survey No. 17483-A, a copy of which is annexed to COB 900, Folio 158, St. Tammany Parish, Louisiana, more particularly described as follows, to-wit:

From the northwest corner of Headright 40, Township 8 South, Range 13 East, go South 28 degs. 15 mins. West, 2340.0 feet to a point; thence South 60 degs. 14 mins. East, 2085.0 feet to a point: thence South 82 degs. 15 mins. East, 3491.4 feet to a point; thence South 82 degs. 45 mins. East, 58.16 feet to a point; South 07 degs. 15 mins. West, 10.0 feet to a point; thence South 82 degs. 45 mins. East, 61.8 feet to the Point of Beginning and the southerly right-of-way line of U.S. Highway 190.

Thence from the Point of Beginning, go along said southerly right-of-way line, South 82 degs. 45 mins. East, 9.5 feet to a point; thence South 04 degs. 19 mins. 50 secs. West, 165.75 feet to a point; thence West 19.55 feet to a point; thence North 07 degs. 45 mins. East, 167.6 feet to the Point of Beginning.

From the northwest corner of Headright 40, Township 8 South, Range 13 East, go South 28 degs. 15 mins. West, 2340.0 feet to a point; thence South 60 degs. 14 mins. East, 2085.0 feet to a point; thence South 82 degs. 15 mins. East, 3491.4 feet to a point; thence South 82 degs. 45 mins. East, 58.16 feet to a point; South 07 degs. 15 mins. West, 10.0 feet to a point; thence South 82 degs. 45 mins. East, 61.8 feet to the Point of Beginning and the southerly right-of-way line of U.S. Highway 190.

From the Point of Beginning, go South 07 degs. 45 mins. West, 167.6 feet to a point; West 0.45 feet to a point; thence North 04 degs. 19 mins. 50 secs. East, 167.85 feet to a point; thence South 82 degs. 45 mins. East, 10.5 feet to the Point of Beginning.
