A resolution approving the holding of an election in St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana, on Saturday, October 20, 2007, to authorize the levy of a special tax therein.

WHEREAS, the Board of Commissioners of St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana (the "Governing Authority"), acting as the governing authority of St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana (the "District"), adopted a resolution on June 12, 2007, calling a special election in the District on Saturday, October 20, 2007, to authorize the levy of a special tax therein; and

WHEREAS, the governing authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of St. Tammany, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to levy and collect the special tax provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to levy and collect the special tax provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of St. Tammany, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, October 20, 2007, at which election there will be submitted the following proposition, towit:

PROPOSITION (MILLAGE RENEWAL)

SUMMARY: 10 YEAR, 10 MILLS PROPERTY TAX RENEWAL FOR ACQUIRING, CONSTRUCTING, IMPROVING, MAINTAINING AND/OR OPERATING FIRE PROTECTION FACILITIES AND EQUIPMENT IN AND FOR ST. TAMMANY FIRE PROTECTION DISTRICT NO. 6, INCLUDING EMERGENCY EQUIPMENT AND SUPPLIES AND FOR PAYING THE COST OF OBTAINING WATER FOR FIRE PROTECTION PURPOSES AND PAYING CHARGES FOR FIRE HYDRANT RENTALS AND SERVICE.

Shall St. Tammany Fire Protection District No. 6 of the Parish of St. Tammany, State of Louisiana (the "District"), levy a ten (10) mills tax on all the property subject to taxation in the District (an estimated \$120,000 reasonably expected at this time to be collected from the levy of the tax for an entire year) for a period of ten (10) years, beginning with the year 2008 and ending with the year 2017, for the purpose of acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment in and for the District, including emergency equipment and supplies and paying the cost of obtaining water for fire protection purposes and paying charges for fire hydrant rentals and service?
