An Ordinance amending the official zoning map of St. Tammany Parish, La, to reclassify a certain parcel located on the southeast corner of LA Highway 59 and Henry Clay Avenue, north of Destin Street, west of Marigny Street and which property comprises a total of 16,884 sq. ft. of land more or less, from its present A-2 (Suburban) District to a LC (Light Commercial) District, Ward 4, District 10. (ZC07-05-024)

Whereas, the Zoning Commission of the Parish of St. Tammany after hearing in accordance with law, Case No. ZC07-05-024, has recommended to the Council of the Parish of St. Tammany, Louisiana, that the zoning classification of the above referenced area be changed from its present A-2 (Suburban) District to a LC (Light Commercial) District (see Exhibit "A") for complete boundaries.

Whereas, the St. Tammany Parish Council has held its public hearing in accordance with law:

Whereas, the St. Tammany Parish Council has found it necessary for the purpose of protecting the public health, safety and general welfare, to designate the above described property as LC (Light Commercial) District.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, in regular session convened that:

SECTION I: The zoning classification of the above described property is hereby changed from its present A-2 (Suburban) District to a LC (Light Commercial) District.

SECTION II: The official zoning map of the Parish of St. Tammany shall be and is hereby amended to incorporate the zoning reclassification specified in Section I hereof.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

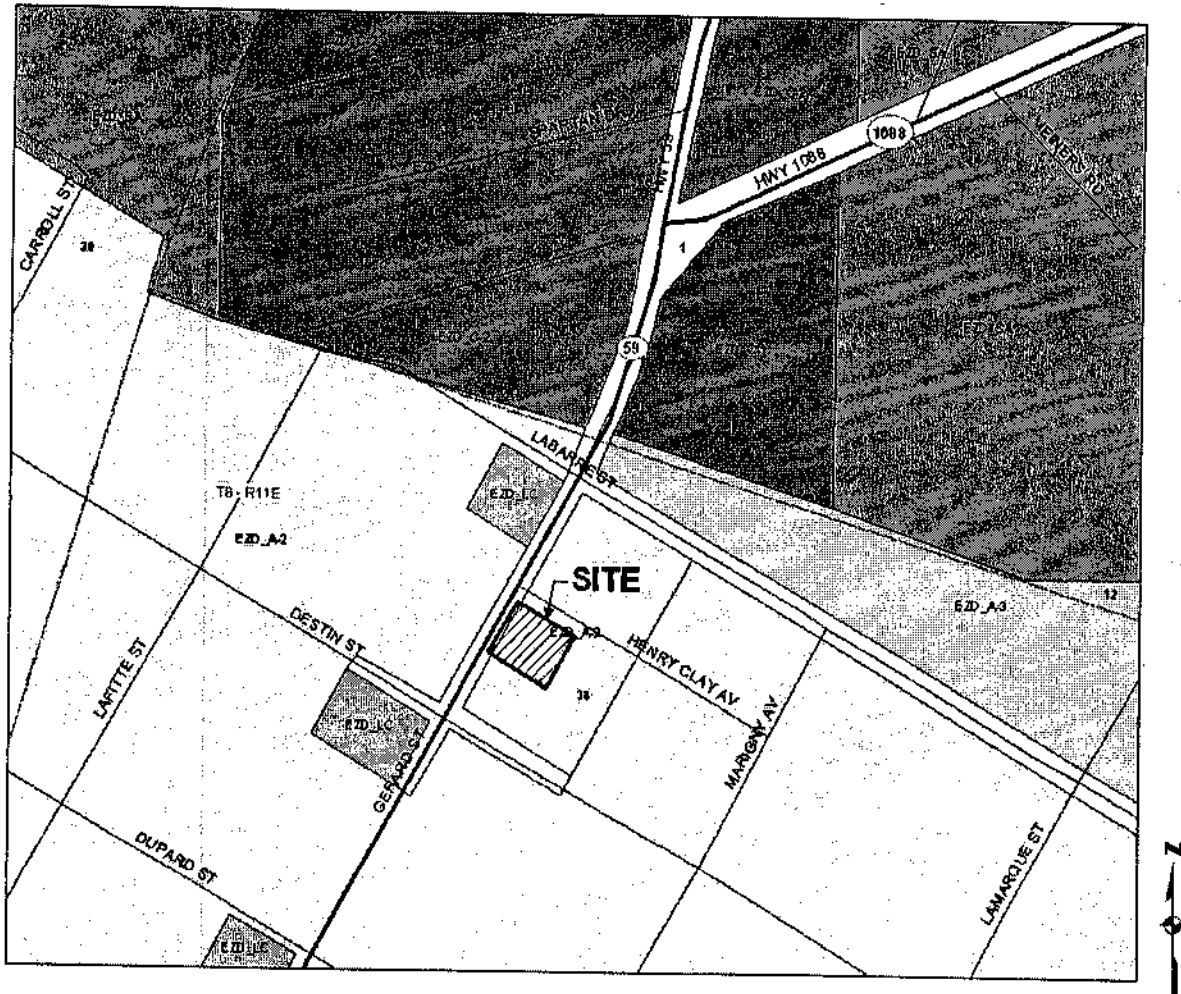

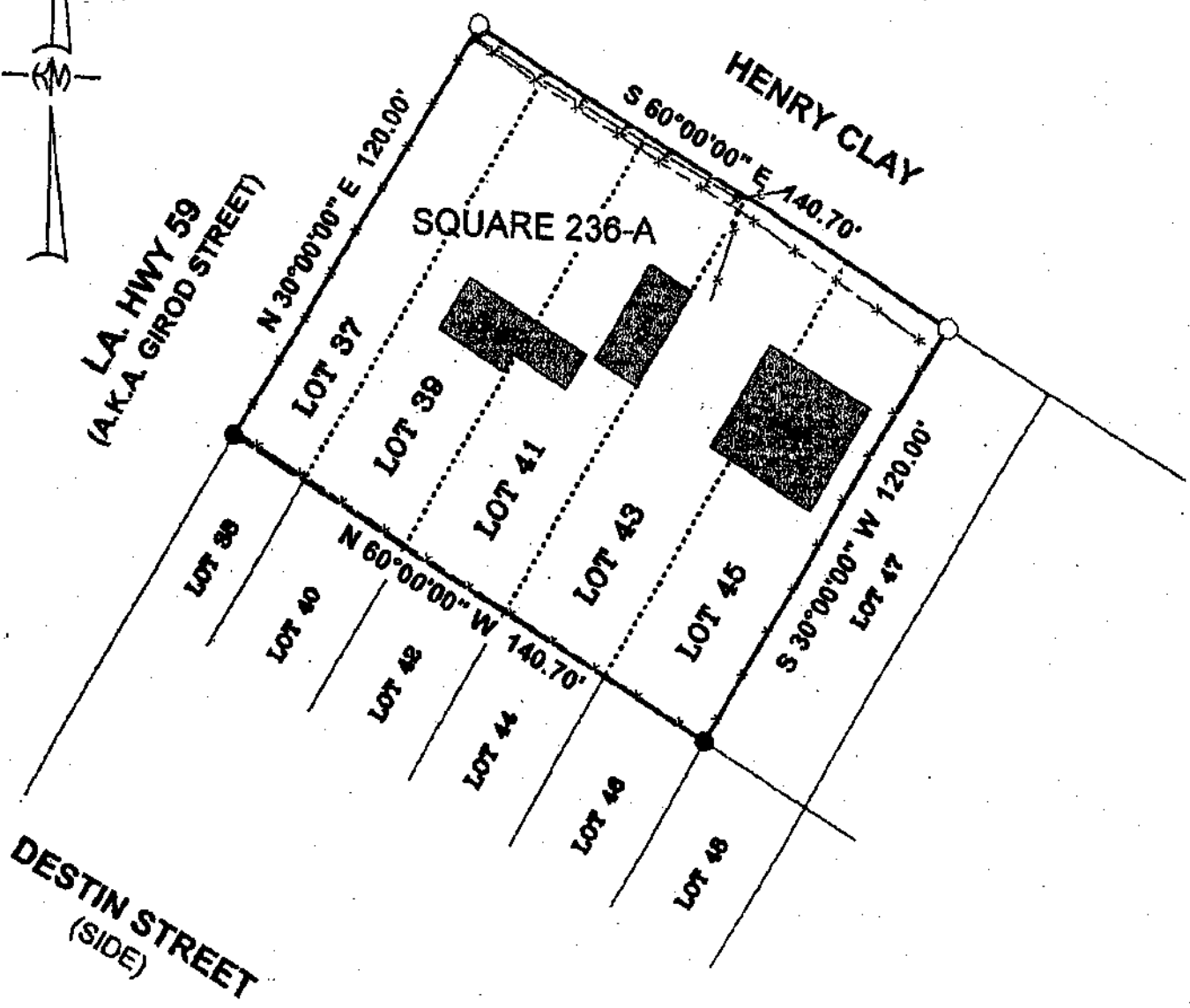

ALL THAT CERTAIN PIECE OR PARCEL OF LAND, together with all buildings and improvements thereon, and all rights, ways, means, privileges, servitudes, prescriptions, and advantages thereunto belonging or in anywise appertaining, situated in and being a part of Square 236-A, said square bounded by State Highway 59 (Gerard Street), Henry Clay Street, and Marigny and Destin Street, in the Town of Mandeville, St. Tammany Parish, Louisiana. From the intersection of State Highway 59 (Gerard Street) and Henry Clay Street as the point of beginning, go along the southerly right of way to Henry Clay Street, in the direction of Marigny Street, a distance of 140.7 feet; thence go in the direction of Destin Street, on a parallel line to State Highway 59 (Gerard Street) a distance of 120 feet to a point; thence go in the direction of State Highway 59 (Gerard Street) on a line parallel to Henry Clay Street, a distance of 140.7 feet to a point on the easterly right of way line of Highway 59 (Gerard Street) in the direction of Henry Clay, a distance of 120 feet to the intersection of the southerly right of way line of the said Henry Clay Street and the easterly right of way line of State Highway 59 (Gerard Street) the point of beginning herefor set.

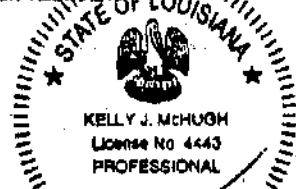
