AN ORDINANCE TO CORRECT THE ROAD INVENTORY TO INCLUDE BOLLIFIELD ROAD; AND TO REMOVE AN APPROXIMATE 2,528 FOOT LENGTH FROM BRANCH CROSSING DRIVE. WARD 3, DISTRICT 2

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road Maintenance System Inventory is amended to include Bollifield Road, located off Branch Crossing Drive, Ward 3, District 2

The Road Inventory is additionally amended to remove approximately 2,528 foot length of Branch Crossing Drive (R03H018), Ward 3, District 2. Branch Crossing Drive's corrected length remaining is 1,845 feet.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.

ADMINISTRATIVE COMMENT

Administrative Department: Public Works
