ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACCEPT THE DONATION OF A PORTION OF LAND FROM PELICAN PARK TO LA HIGHWAY 1088 FROM DAVID MOORE AND MARGERY HANISEE MOORE AND TO INCLUDE SAME INTO THE ROAD MAINTENANCE SYSTEM, WARD 4, DISTRICT 7, AS MORE FULLY DESCRIBED HEREIN:

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that:

WHEREAS, the Donation by David Moore and Margery Hanisee Moore of a portion of land from Pelican Park to Louisiana Highway 1088 is accepted, and same shall be incorporated into the St. Tammany Parish Selective Road Maintenance System Inventory; and

WHEREAS, the Parish President is hereby authorized to execute any and all documents necessary in connection with said acceptance of donation by David Moore and Margery Hanisee Moore; and

WHEREAS, the Department of Public Works will maintain the operation and maintenance of the road; and

WHEREAS, the portion of land is described as follows:

A portion of Section 5, T8S, R12E, Section 8, T8S, R12E

Section 44, T8S, R12E

THE PARISH OF ST. TAMMANY HEREBY ORDAINS to authorize the Office of the Parish President to accept the Dedication and Donation of said property by David Moore and Margery Hanisee Moore for the purpose of regional drainage retention.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.
