
Subject: Louisiana National Guard Use of St. Tammany Parish Property

Dear Mr. Crouch:

On behalf of the Military Department, State of LA Contracting Officer and Louisiana National Guard – Construction and Facilities Management Office, we are requesting use of St. Tammany Parish property located on Columbia Street adjacent to the current and new National Guard property. We are requesting use of the existing asphalt parking area and asphalt driveway located between the south property line of the proposed Readiness Center site and the existing chain link fence located along the north side of the existing brick building which is situated on the far west side of the Fairgrounds site. The requested area is approximately 75' wide by 280' long; it will be used for temporary construction offices, jobsite parking, as well as staging of some military vehicles when needed. This property will be used for the duration of construction (15 to 18 months) beginning in January 2007.
