RESOLUTION ESTABLISHING MILLAGE RATE FOR THE YEAR 2007.

WHEREAS, in accordance with the provisions of Article VII, Section 23 (B) and (C) of the 1974 Louisiana Constitution and R.S.47:1705(B)(1)and (2), a taxing authority is required to adopt a Resolution to set forth and designate the millage rate(s) for 2007.

NOW, THEREFORE, BE IT RESOLVED BY THE ST. TAMMANY PARISH COUNCIL, in a public hearing held on July 5, 2007, which hearing was conducted in accordance with the open meetings law and the additional requirements of Article VII, Section 23(C) of the Constitution, that the following millage rate(s) be and they are hereby levied upon the dollar of the assessed valuation of all property subject to ad valorem taxation within St. Tammany Parish for the year 2007, for the purpose of raising revenue:
