AN ORDINANCE TO CORRECT THE ROAD INVENTORY TO INCLUDE LANGE LANE, LAWRENCE LANE, SANDY HOLLOW, ELIZABETH MAE LANE, LIVINGSTON LANE, AND AN 1,890 FOOT EXTENSION OF ROSE STREET; TO REMOVE MIRANDA ROAD FROM THE INVENTORY; TO ADJUST THE LENGTH OF WEST CHESTNUT STREET FROM 2,910 FEET TO 1,541 FEET; ALSO TO CORRECT THE DRAINAGE INVENTORY TO INCLUDE DITCH LOCATED OFF MONTMARTRE STREET, AND DITCH LOCATED OFF DOWNS AVENUE. WARDS 2, 4, 6, 7, & 10, DISTRICTS 2, 3, 6 & 7

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road Maintenance System Inventory is amended to include:

1. Lange Lane, approx. 1,455 feet, located south off V & M Road R10F037, Ward 10, District 7
2. Lawrence Lane, approx. 1,455 feet, located south off V & M Road R10F037, Ward 10, District 7
3. Sandy Hollow, approx. 825 feet, located off John Messer Road R06F009, Ward 6, District 6
4. Elizabeth Mae Lane, approx. 1,100 feet, located south off Putt Moran Loop R06L004, Ward 6, Dist. 6
5. Livingston Lane, approx. 1,190 feet, located off Howard O'Berry Road R06E018. Ward 6, District 6
6. An 1,890 foot extension of Rose Street R10D018.

Also, the Road Inventory is amended to remove:

1. Miranda Road R02X019, located off Perry Road, Ward 2, District 2
2. Approx. 1,369 feet from the maintained length of West Chestnut Street R07E054 (total length maintained is 1,541 feet).

Additionally, the Drainage Inventory shall be amended to include the following ditches:

1. Lateral D04EW02038 located @ 805 Montmartre Street, R04E038, Ward 4, District 7
2. Lateral D10EW02003 located next to 74254 Downs Avenue R10E003, Ward 10, District 6

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
