ORDINANCE TO AMEND ORDINANCE COUNCIL SERIES NO. 07-1562 TO REMOVE CORE ROAD FROM THE ROADS BEING ACCEPTED INTO THE MAINTENANCE SYSTEM. WARD 2, DISTRICT 3

WHEREAS, Ordinance Council Series No. 07-1562, adopted May 3, 2007 corrected the road inventory to include certain roads into the Parish road maintenance system, of which Core Road was included erroneously, and is in fact located within the Village of Folsom; and

WHEREAS, it is the desire of this Council that this error be corrected and the road included in the above mentioned ordinance be deleted from same; and also be removed from the Parish's road maintenance system; and

WHEREAS, specific road to be removed from the inventory is Core Road, located south off South Hay Hollow Road (R02F003), Ward 2, District 3.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: Ordinance Council Series No. 07-1562, adopted May 3, 2007, is hereby amended to remove Core Road from the roads being accepted into the maintenance system as said Core Road is located within the Village of Folsom.

SECTION II: The Parish Department of Public Works is hereby directed to remove Core Road from the Parish Road Maintenance System.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

EFFECTIVE DATE: This ordinance shall become effective fifteen (15) days after adoption
