ORDINANCE TO AMEND THE PARISH CODE OF ORDINANCES, CHAPTER 18, BY ADDING A NEW ARTICLE THERETO CREATING THE "COLONIAL PINNACLE NORD DU LAC ECONOMIC DEVELOPMENT DISTRICT", DEFINING THE BOUNDARIES THEREOF FROM WHICH AREA LOCAL AND STATE SALES TAX INCREMENTS WILL BE DETERMINED AND USED TO FINANCE ECONOMIC DEVELOPMENT PROJECTS ON A CASH BASIS TO FUND A PORTION OF THE COST OF ECONOMIC DEVELOPMENT PROJECTS IN ACCORDANCE WITH AND AS AUTHORIZED BY PART II OF CHAPTER 27 OF TITLE 33 OF THE LOUISIANA REVISED STATUTES OF 1950, AS AMENDED; AND PROVIDING FOR OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, the Parish of St. Tammany, State of Louisiana (the "Parish") may use local and State sales tax increments on a cash basis, in accordance with Part II of Chapter 27 of Title 33 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 33:9038.31 through 33:9038.42, inclusive) (the "Act"), to provide funds needed to finance economic development projects; and

WHEREAS, the Parish desires to create a special trust fund pursuant to the Act to be designated the "Colonial Pinnacle Nord du Lac Economic Development District Trust Fund" the purpose of which will be to fund economic development projects selected by the hereinafter defined District; and

WHEREAS, in order to accomplish the funding of projects in accordance with the requirements of the Act and to fund the Colonial Pinnacle Nord du Lac Economic Development District Trust Fund, the Parish Council proposes to create an economic development district within the Parish to be known as the "Colonial Pinnacle Nord du Lac Economic Development District, State of Louisiana" (the "District"), from which District local and State sales tax increments are expected to be determined and used to fund the Colonial Pinnacle Nord du Lac Economic Development District Trust Fund and reimburse CPNDL Joint Venture, a joint venture between Colonial Properties Trust and the Robert B. Aikens Co. (the "Developer") or its designee.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that:

SECTION 1: All of the above "Whereas" clauses are adopted as part of this ordinance.

SECTION 2: There is hereby created an economic development district within the Parish, to be named the "Colonial Pinnacle Nord du Lac Economic Development District, State of Louisiana", having the geographical boundaries set forth in Exhibit A attached hereto, which Exhibit A is hereby incorporated in and made a part of this Ordinance, all pursuant to the Act. As provided by the Act, the governing body of the District shall be the Parish Council. As provided by the Act, the District shall be a political subdivision of the State of Louisiana and shall possess such powers and authority and have such duties as provided in the Act and other law.

SECTION 3: There has been published two times in the *St. Tammany Farmer*, the official journal of the Parish, a notice in the form attached hereto as Exhibit B, describing the boundaries of the District and informing the citizens of the date of considerations of this ordinance.

SECTION 4: This Ordinance shall be published one time in the St. Tammany Farmer.

SECTION 5: There is hereby created a special trust fund, to be named the "Colonial Pinnacle Nord du Lac Economic Development District Trust Fund" the purpose of which will be to fund economic development projects selected by the District.

SECTION 6: The Parish President and the Council Clerk are hereby authorized to do any and all things necessary and incidental to carry out the provisions of this Ordinance.

SECTION 7: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 8: If any provision of this ordinance shall be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this ordinance, but this ordinance shall be construed and enforced as if such illegal or invalid provisions had not been contained herein. Any constitutional or statutory provision enacted after the date of this ordinance which validates or makes legal any provision of this ordinance which would not otherwise be valid or legal, shall be deemed to apply to this ordinance.

SECTION 9: This Ordinance shall become	e effective immediately upon final adoption.

six (6) pages constitute a true and correct copy of the proceedings taken by said Council on June 7, 2007,
amend the Parish Code of Ordinances, Chapter 18, by adding Article, to create an economic
development district, and specifically Colonial Pinnacle Nord Du Lac Economic Development District,
State of Louisiana, defining the boundaries thereof from which area the local and state sales tax
increments will be determined and used to finance economic development projects on a cash basis to fund
a portion of the cost of economic development projects in accordance with and as authorized by Part II of
Chapter 27 of Title 33 of the Louisiana Revised Statutes of 1950, as amended; and providing for other
matters in connection with the foregoing.
