3. Fill and sod all sink holes and ruts in median and shoulders;
4. Remove pipes and plastic chains from in front of "Daiquiris and Cream" property within roadway right of way;
5. Replace missing street name sign;
6. Replace missing "stop signs";

4. Detention pond slopes need to be graded to eliminate rainwash gullies; erosion control needs to be applied and a mature stand of grass existing before the Parish can accept for operation and maintenance.

4. Revise as-built to show asphalt path between lots 241/242;
5. Erosion protection is needed on outfall canal banks between lot 301/302;
6. Replace blue reflectors as needed.
