ORDINANCE TO CORRECT THE ROAD INVENTORY TO INCLUDE A PORTION OF MCDONALD ROAD, TRAVIS CORE ROAD, A PORTION OF ROSE STREET, CORE ROAD, A PORTION OF JENKINS ROAD, A PORTION OF FOURTH AVENUE, A PORTION OF OGISE RICHARDSON ROAD, RYAN ROAD, PATRICK LANE, AND DREAMLAND COURT. WARDS 1, 2, 3, 6, & 10, DISTRICTS 1, 2, 3, 5, & 6

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road Maintenance System Inventory is amended to include:

1. A portion of McDonald Road (R01G006), located west off Highway 1077, approximately 434 feet. Ward 1, District 1
2. Travis Core Road, located west off Fauchaux Road (R02J004). Ward 2, District 3
3. A portion of Rose Street (R10D018), located north off Highway 36, approximately 1,890 feet. Ward 10, District 3
4. Core Road, located south off South Hay Hollow Road (R02F003). Ward 2, District 3
5. A portion of Jenkins Road (R03L101), located south off Soell Drive, approximately 1,000 feet. Ward 3, District 5
6. A portion of Fourth Avenue (R03L008), located northwest off Helenbirg Road, approximately 310 feet, Ward 3, District 5
7. A portion of Ogise Richardson Road (R06A013), located west off Highway 41, approximately 1,400 feet, Ward 6, District 6
8. Ryan Road, located north off Million Dollar Road (R02O003), Ward 2, District 2
9. Patrick Lane, located south off Rogers Hill Road (R03G009), Ward 3, District 2
10. Dreamland Court, located north off Bruhl Road (R02N028), Ward 2, District 2

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
