ORDINANCE TO AMEND ORDINANCE COUNCIL SERIES NO. 07-1496, ADOPTED JANUARY 4, 2007, TO CHANGE THE POLLING LOCATION FOR PRECINCTS 401 AND 421.

WHEREAS, Ordinance C.S. No. 07-1496, adopted January 4, 2007, provided for changes to polling locations in several precincts and received U.S. Justice Department approval; and

WHEREAS, the polling location for Precincts 401 and 421 was moved to Cedarwood Elementary School for the convenience of voters and to avoid future overcrowding at Mandeville High School; and

WHEREAS, the Parish Council has received a request from the St. Tammany Parish Clerk of Court to return Precincts 401 and 421 to Mandeville High School because of limited space concerns at Cedarwood Elementary School.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that Ordinance Council Series No. 07-1496, adopted January 4, 2007, be amended to change the polling location for Precincts 401 and 421 from its current location at Cedarwood Elementary School to Mandeville High School, to be effective beginning on the next eligible election day of 2007.

BE IT FURTHER ORDAINED that the Registrar of Voters is hereby directed to process any notification of polling location changes by issuance of new voter registration cards to individual voters in the areas affected by this change, if necessary.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not effect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon final adoption.
