ORDINANCE TO ADOPT A VOLUNTARY DEVELOPMENTAL AGREEMENT BETWEEN THE PARISH OF ST. TAMMANY AND THE DEVELOPER OF CYPRESS PARK SUBDIVISION, LOCATED IN WARD 7, DISTRICT 7

WHEREAS, the developer of Cypress Park, an approved Subdivision of Record, has agreed to enter into a voluntary Settlement (and incorporated Developmental) Agreement and Release with the Parish of St. Tammany (See Exhibit 1); and

WHEREAS, the St. Tammany Parish Council has held a public hearing and concurred with the proposed agreement and does hereby confirm that said agreement is mutually acceptable, binding on all parties, and shall derive benefits for the development and to the Parish.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it hereby accepts and enters into said voluntary Settlement (and incorporated Developmental) Agreement and Release with the developer of the Cypress Park Subdivision (See Exhibit 1), and its successors and/or assigns, as well as any other boards, commissions, organizations or districts duly created or endorsed by the Parish Council that may be a party hereto.

BE IT FURTHER ORDAINED that the agreement shall be recorded in the records of the Clerk of Court of St. Tammany Parish, if applicable, and this ordinance shall serve as an attachment thereto.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance is held to be invalid, such invalidity shall not affect other parts or provisions which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective upon signature of the Parish President.
