ORDINANCE ESTABLISHING A "NO THRU TRUCKS" ZONE ON PINEHURST BLVD., MONTGOMERY BLVD., DEVONSHIRE DR., KINGSPPOINT BLVD., FOXCROFT ST. AND BROOKTER ST. (WARD 8, DISTRICTS 13)

WHEREAS, the St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the parish; and

WHEREAS, St. Tammany Parish has experienced an increase in cut through truck traffic, proceeding at unsafe speeds on Pinehurst Blvd., Montgomery Blvd., Devonshire Dr., Kingspoint Blvd., Foxcroft St. and Brookter St., beginning at their intersections with Voters Road; and

WHEREAS, affected citizens requested control measures be taken to address this unsafe situation on Parish roads.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO THRU TRUCKS" ZONE is hereby established on, Pinehurst Blvd., Montgomery Blvd., Devonshire Dr., Kingspoint Blvd., Foxcroft St. and Brookter St. as indicated on the attached traffic plan by the Department of Engineering. WARD 8, DISTRICT 13.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION IV: This ordinance shall become effective immediately upon final adoption.
