ORDINANCE ESTABLISHING A "NO PARKING" ZONE ON A PORTION OF AIRPORT ROAD AT THE OAKMONT SUBDIVISION ENTRANCE AND A PORTION OF THE ADJACENT PEDESTRIAN WALKING PATH, WARD 9, DISTRICT 11

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO PARKING" zone is hereby established on a portion of Airport Road (R-09-C037), specifically on the east side shoulders of the Oakmont Subdivision Entrance at Oakmont Drive, and along the adjacent pedestrian path from the property line of 61260 Airport Road proceeding in a northerly direction to the Oakmont Subdivision entrance at Airport Road, Ward 9, District 11.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at this location according to the attached Engineering diagram.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after final adoption.
