ORDINANCE ESTABLISHING A "NO PARKING" ZONE ON BOTH SIDES OF OIL ROW. WARD 3, DISTRICT 2

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO PARKING" zone is hereby established on both sides of Oil Row (3-H-17).

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at this location, in accordance with the attached Engineering data.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective immediately upon final adoption.

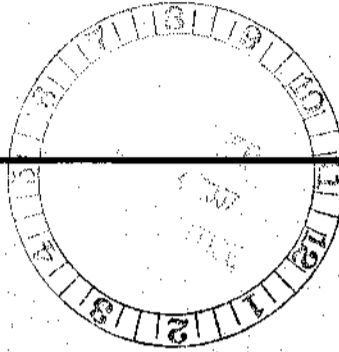

4- "No Parking" R8-3

The Department of Engineering recommends the installation of No Parking signs on Oil Row

As per MUTCD, when signs with arrows are used to indicate the restricted parking zones, the signs with the arrows should be set at an angle of not less than 30 degrees and not more than 45 degrees with the line of traffic flow in order to be visible to approaching traffic. **Please set the signs, with the arrows only, to an angle of not less than 30 degrees and not more than 45 degrees with the line of the traffic flow**

1. Install: "No Parking" on the west side of Oil Row, 40' from the Oil Row and Hard Hat Dr. Intersection.
2. Install: "No Parking" on the east side of Oil Row, directly across from Job #1.
3. Install: "No Parking" on the east side of Oil Row, 75, from first existing driveway. Signs should be located just before cul-de-sac.
4. Install: "No Parking" on the west side of Oil Row, directly across from Job #3.

Please install signs in accordance with MUTCD standards and see the attached sketch. Thank you for your assistance. If you have any questions, please let me know.
