AN ORDINANCE TO CORRECT THE ROAD INVENTORY TO INCLUDE SMITH & JONES ROAD, A STREET, AND 11TH STREET; TO ADD AN APPROXIMATE 552 FOOT EXTENSION OF JACKSON STREET, AND AN APPROXIMATE 1,265 FOOT EXTENSION OF SUN DRIVE; AND TO REMOVE AN APPROXIMATE 1,634 FOOT LENGTH FROM HUNT ROAD. WARDS 2, 3, 4, 5 & 7, DISTRICTS 1, 2, 6 & 7

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road Maintenance System Inventory is amended to include:

- 1. Smith & Jones Road, located off Pichon Road, Ward 7, District 7;
2. A Street, located north of 12TH Street (R03A023), Ward 3, District 1;
3. 11th Street, located west off Highway 190, Ward 3, District 1;
4. An approximate 552 foot extension of Jackson Street (R04E192), Ward 4, District 7; and;
5. An approximate 1,265 foot extension of Sun Drive (R05G011), Ward 5, District 6.

The Road Inventory is additionally amended to remove approximately 1,634 foot length of Hunt Road (R02O013), Ward 2, District 2. Hunt Road's corrected length remaining is 1,500 feet.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
