ORDINANCE ESTABLISHING A "NO PARKING" ZONE AND ESTABLISHING A "SPEED LIMIT" OF 15 MPH FOR THE ENTIRE LENGTH OF SON MOORE ROAD (8-A-8), WARD 8, DISTRICT 14.

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the parish; and

WHEREAS, St. Tammany Parish has experienced an increase in traffic on Son Moore Road warranting no parking and speed limit signs on said roadway; and

WHEREAS, affected citizens have requested measures be taken to address this traffic control issue on a parish road.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO PARKING" zone and "15 MPH SPEED LIMIT" is hereby established for the entire length of Son Moore Road (8-A-8).

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at this location, in accordance with the attached Engineering data, (Ward 8, District 14).

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective immediately upon final adoption.

5-"Speed Limit 15"  
3-"Slow Children @ Play"

3-"NO PARKING" (R8-3)

The Department of Engineering recommends the installation of signs on Son Moore Rd.  
Signage to be changed from existing "Speed Limit 20" to "Speed Limit 15".

**SPEED LIMIT**

- 1.-2. Install (2) "Speed Limit 15" and (2) "SC@P" signs on each side of Son Moore Rd. 110' from the Son Moore/N. Son Moore intersection, each facing oncoming traffic.
3. Install "Speed Limit 15" sign 400' from mailbox 3837 (A. Cooper), facing north.
4. Install "Speed Limit 15" and "SC@P" sign across from Job #3 facing south.
5. Install "Speed Limit 15" sign 100' from the Son Moore/Hwy 11 intersection.

**NO PARKING**

1. Install "NO PARKING" R7-1 (Left Arrow) sign on the east side of Son Moore,

1119' from the south Son Moore/Hwy 11 intersection.

2. Install "NO PARKING" R7-1 (Right Arrow) sign on the west side of Son Moore, 1119' from the south Son Moore/Hwy 11 intersection.
3. Install "NO PARKING" R7-1 (Right Arrow) sign on the east side of Son Moore, 710' from Job #1.
4. Install "NO PARKING" R7-1 (Left Arrow) sign on the west side of Son Moore, 710' from Job #2.
- 5.-6. Install (2) "NO PARKING" signs R8-3 on both sides of Son Moore, between Jobs 1 and 3 and Jobs 2 and 4. Each facing the road.
7. Install "NO PARKING" sign R7-1 (Right Arrow) on the north side of Son Moore, 20' east of the Son Moore/N. Son Moore intersection.
8. Install "NO PARKING" R7-1 (Left Arrow) sign on the north side of Son Moore, 20' from the north Son Moore/Hwy 11 intersection.
9. Install: "NO PARKING" sign on the north side of SON MOORE, in between Jobs 7 and 8.

Please install signs in accordance with MUTCD standards and see the attached sketch.
