ORDINANCE ESTABLISHING A "NO PARKING" ZONE ON A PORTION OF ST. JOSEPH STREET. WARD 7, DISTRICT 7.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO PARKING" zone is hereby established on a portion of St. Joseph Street (7-E-6), specifically, on the South side of St. Joseph Street starting at 14th Street, proceeding Westerly to 15th Street.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations in accordance with the attached Engineering data only for the above specified area.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective immediately upon final adoption.

The Department of Engineering recommends the installation of No Parking signs on St Joseph, St Mary, and 14th St.

As per MUTCD, when signs with arrows are used to indicate the restricted parking zones, the signs with the arrows should be set at an angle of not less than 30 degrees and not more than 45 degrees with the line of traffic flow in order to be visible to approaching traffic. **Please set the signs, with the arrows only, to an angle of not less than 30 degrees and not more than 45 degrees with the line of the traffic flow**

- ✕ 1. Install: "No Parking Any Time" (Left Arrow) 85' west of 12th St, on St Joseph St., with the sign facing north.
- ✕ 2. Install: "No Parking" 60' east of 13th St., on St Joseph St., with the sign facing north.
- ✕ 3. Install: "No Parking" 115' east of 14th St., on St Joseph St., on property line with the sign facing north.
- * 4. Install: "No Parking" on property line at the fence corner between 14th and 15th St. facing north.

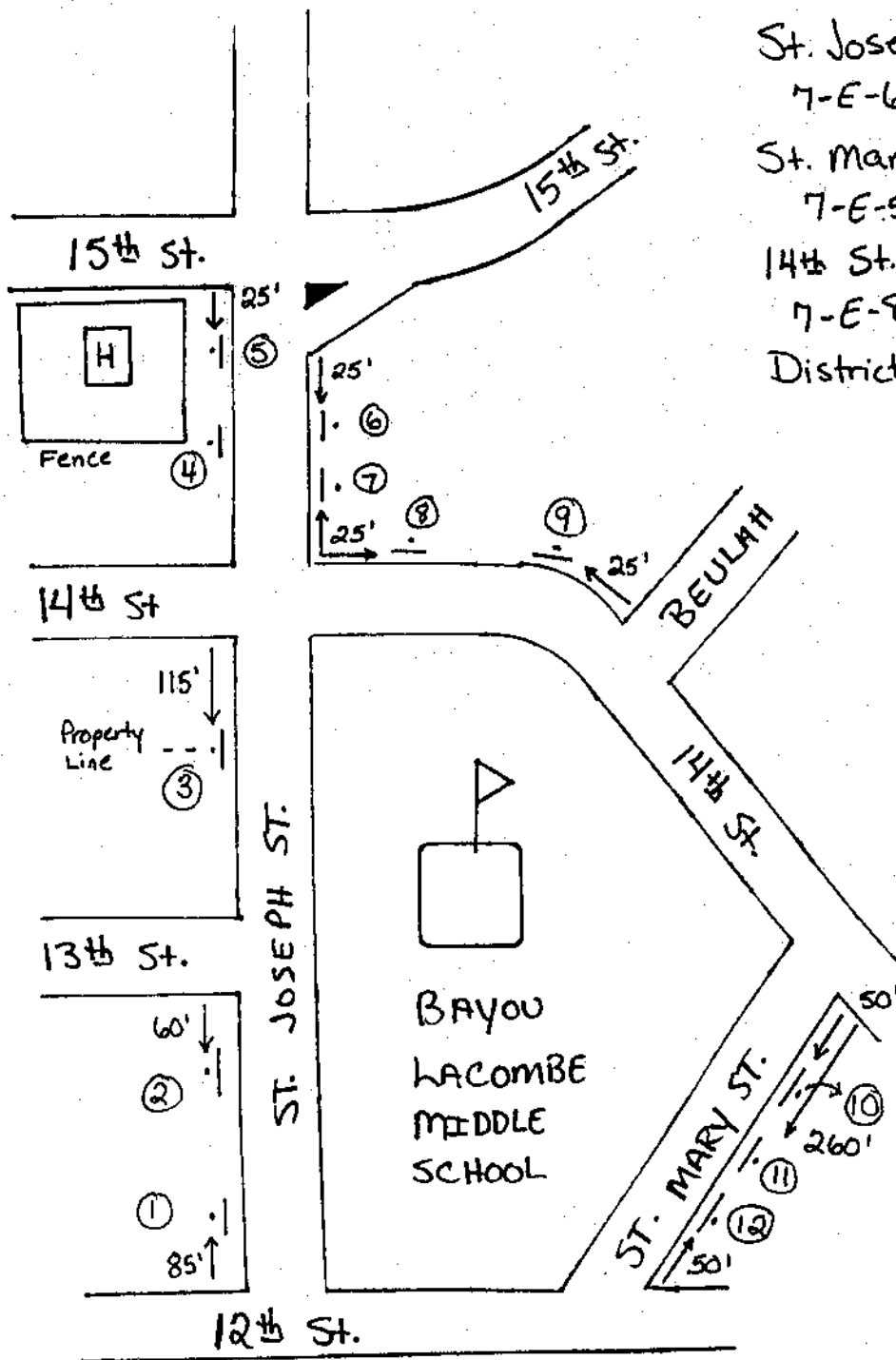
- ~~5.~~ Install: "No Parking Any Time" (**Right Arrow**) 25' east of 15th St, on St Joseph St., with the sign facing north.
- ~~X~~ Install: "No Parking Any Time" (**Right Arrow**) 25' east of 15th St, on St Joseph St., with the sign facing south.
- ~~X~~ Install: "No Parking Any Time" (**Left Arrow**) 25' west of 14th St, on St Joseph St., with the sign facing South.
- ~~X~~ Install: "No Parking Any Time" (**Right Arrow**) 25' north of St Joseph St., on 14th St with the sign facing east.
- ~~X~~ Install: "No Parking Any Time" (**Left Arrow**) 25' South of Beulah, on 14th St., with the sign facing east.
- ~~X~~ Install: "No Parking Any Time" (**Right Arrow**) 50' west of 14th St, on St Mary St., with the sign facing south.
- ~~X~~ Install: "No Parking" 260' east of 14th St., on St Mary St., on Property Line with the sign facing south.
- ~~X~~ Install: "No Parking Any Time" (**Left Arrow**) 50' west of 12th St, on St Mary St., with the sign facing south.
