AN ORDINANCE TO CORRECT THE ROAD INVENTORY TO INCLUDE AN APPROXIMATE 985 FOOT EXTENSION OF SILAS THOMAS ROAD; AN APPROXIMATE 1,861 FOOT EXTENSION OF DENDINGER ROAD; AN APPROXIMATE 277 FOOT EXTENSION OF SCHOKLEY DRIVE, AN APPROXIMATE 749 FOOT EXTENSION OF MAYFAIR ROAD, A REDUCTION OF APPROXIMATELY 2,505 FEET OF SIPES ROAD; AND A REORGANIZATION OF PARLANGE DRIVE, PARLANGE DRIVE NORTH, PARLANGE DRIVE EAST, PARLANGE DRIVE SOUTH, PARLANGE DRIVE WEST AND E. LEG. WARDS 6 & 8, DISTRICTS 6, 9 & 13

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road Maintenance System Inventory is amended to include:

1. An approximate 985 foot extension of Silas Thomas Road (R06H006), Ward 6, District 6;
2. An approximate 1,861 foot extension of Dendinger Road (R06M002), Ward 6, District 6;
3. An approximate 277 foot extension of Schokley Drive (R08Q010), Ward 8, District 13;
4. An approximate 749 foot extension of Mayfair Road (R08V052), Ward 8, District 13;
5. A reduction of approximately 2,505 feet of Sipes Road (R06H049), Ward 6, District 6;

Additionally, the inventory is amended to reflect the following reorganization of roads:

6. Rename Parlange Drive North (R08E010) as Parlange Drive, and add an approximate 3,520 foot extension;
7. Remove Parlange Drive East (R08E110) from inventory (length added to Parlange Drive)
8. Remove Parlange Drive South (R08E210) from inventory (length added to Parlange Drive)
9. Remove Parlange Drive West (R08E310) from inventory (length added to Parlange Drive)
10. Remove E. Leg (R08E111) from inventory (length added to Parlange Drive), Ward 8, District 6

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
