ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY THROUGH THE OFFICE OF THE PARISH PRESIDENT TO ENTER INTO AN ACT OF EXCHANGE OF LAND COMPRISING A PORTION OF PINNACLE PARKWAY FOR THE NEW RIGHT-OF-WAY FOR PINNACLE PARKWAY, MORE FULLY DESCRIBED HEREIN.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that:

SECTION 1. The Office of the Parish President is authorized to enter into an exchange of a portion of Pinnacle Parkway located in Section 47, Township 7 South, Range 11 East, containing .97 acres (Description "A") for a portion of land representing a realignment of Pinnacle Parkway located in Section 47, Township 7 South, Range 11 East, containing .97 acres, all in accordance with the Act of Exchange and set forth in Exhibits "A" and "B" attached hereto and made part hereof.

SECTION 2. The Act of Dedication and Donation by Wainer Brothers, et al for a parcel of land located in Section 47, Township 7 South, Range 11 East, St. Tammany Parish, Louisiana is accepted. The roadway shall be incorporated into the St. Tammany Parish Selective Road Maintenance System Inventory upon construction of the roadway in conformity with all St. Tammany Parish Regulations and certified by the St. Tammany Parish Department of Engineering. The Parcel of land in Description "A" shall be transferred to Wainer Brothers, et al in fee simple ownership free and clear of any public dedication or rights as a roadway and the parcel of land in Description "B" transferred to St. Tammany Parish and shall be dedicated for public use as a roadway.

SECTION 3. The Parish President and/or C.A.O. are hereby authorized to execute any and all documents necessary in connection with said Act of Exchange and Acceptance of Dedication of Roadway.

SECTION 4. The Parish President and/or C.A.O. are hereby authorized to execute any and all documents and instruments in furtherance of the above on behalf of St. Tammany Parish.
