ORDINANCE AUTHORIZING THE EXECUTION OF AN AGREEMENT BETWEEN ST. TAMMANY PARISH GOVERNMENT AND HIAWATHA RECREATIONAL PARK FOR THE USE OF THE PARISH SULLIVAN ROAD RECREATIONAL PROPERTY, WARD 9, DISTRICT 14.

WHEREAS, St. Tammany Parish Government owns certain lots and rights-of-way comprising a 3.976 acre parcel of land in Hiawatha Park Subdivision, identified and known as "Sullivan Road Recreational Property"; and

WHEREAS, Hiawatha Recreational Park, a Louisiana Non-Profit Corporation duly registered with the Office of the Secretary of State, desires to sponsor, establish, construct and maintain recreational programs and facilities on the Sullivan Road Recreational Property for the benefit and use of the public within Hiawatha Park Subdivision and surrounding communities; and

WHEREAS, a use agreement between the Parish and Hiawatha Recreational Park authorizing the non-profit corporation to operate, maintain and be responsible for the property will benefit both parties by guaranteeing the preservation and improvement of the property while expanding the recreational opportunities for the Hiawatha Park Subdivision and surrounding communities.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS to authorize the execution of an appropriate use agreement between St. Tammany Parish Government and Hiawatha Recreational Park for the use, development and maintenance of the Sullivan Road Recreational Property more fully described as follows:

The eastern 41.30 foot portion of Lot 116 as measured in a westerly direction along its southern boundary, Lots 117 through 133, the unopened right-of-way of Cherokee Street south of Sullivan Road, the unopened right-of-way of Mohawk Street west of Creek Street and a 128.2 foot portion of the unopened right-of-way of Choctaw Street west of its intersection with Cherokee Street, comprising a 3.976 acre parcel more or less, all in Hiawatha Park Subdivision, Section 9, Township 9 South, Range 14 East, St. Tammany Parish.

BE IT FURTHER ORDAINED that Parish President Kevin Davis, or his designee, is hereby authorized to negotiate and execute any necessary and appropriate documents in furtherance of an agreement, on behalf of Parish Government, with Hiawatha Recreational Park

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

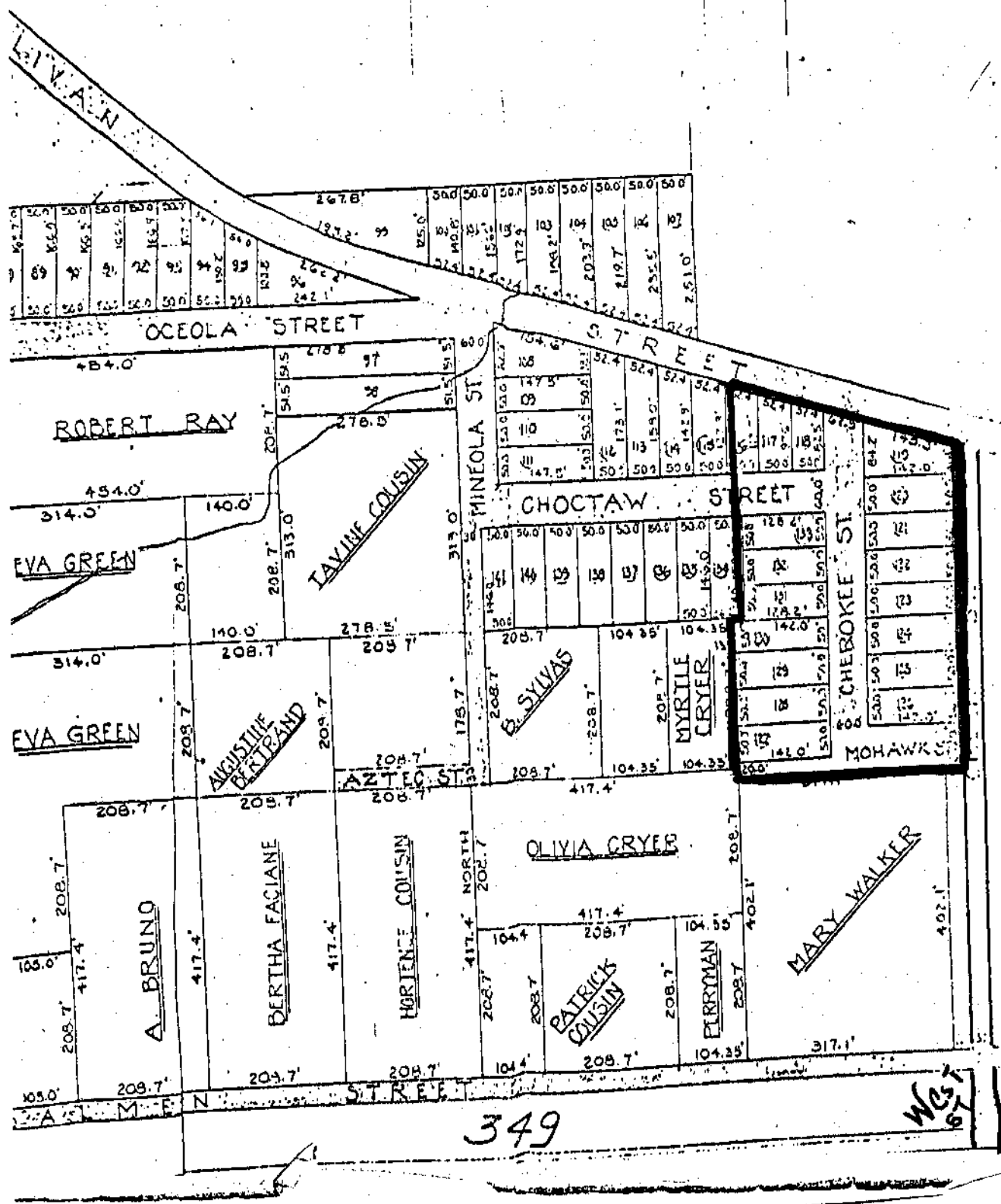

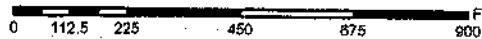
