ORDINANCE ESTABLISHING A "NO PARKING" ZONE ON BOTH SIDES OF A PORTION OF WAXWING DRIVE (WARD 6, DISTRICT 10)

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO PARKING" zone is hereby established on both sides of a portion of Waxwing Drive (4-E-174), specifically, on each side of Waxwing Drive, beginning 30' from mailbox 731- and proceeding 85' from mailbox 731, as per the attached drawing.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at this location, in accordance with the attached Engineering data.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

DATE OF ENACTMENT: This ordinance shall become effective immediately upon final adoption.

4-"NO PARKING" signs (R8-3)

The Department of Engineering recommends the installation of signage on Waxwing Dr

1. Install (2) "NO PARKING" signs on each side of the road, 30' from mailbox 731 on Waxwing Dr. Signs should align with the start of the curb.
2. Install (2) "NO PARKING" signs on each side of the road, 85' from mailbox 731 on Waxwing Dr. Signs should align with the start of the rail located on the Lateral Ditch.

Please install signs in accordance with MUTCD standards and see the attached sketch.
