ORDINANCE ACCEPTING FINALIZED SUBDIVISIONS INTO THE ROAD & DRAINAGE INVENTORIES, SPECIFICALLY CASTINE OAKS, PHASE 1; VERSAILLES, PHASE 5C; AND ENTERING THE RIGHT OF WAY IN TAMMANY TERRACE, PHASE 1 SUBDIVISIONS. WARDS 3 & 4, DISTRICTS 1, 2 & 10

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: All of the area within right-of-way, the road base, surface, drainage ditches, culverts, laterals, canals, and appurtenances thereunto belonging to or otherwise appertaining to the below indicated developments and authorized in the Resolutions stated shall be incorporated into the Parish Selective Maintenance System.

SECTION II: All Parish regulations, policies, procedures and operating methods pertaining to the Parish Selective Maintenance System shall apply to the aforementioned developments.
