ORDINANCE TO RESCIND ORDINANCE 08-1829, ADOPTED JUNE 3, 2008, AUTHORIZING THE PLACEMENT OF STOP SIGNS AT THE INTERSECTION OF PINE STREET EXTENSION ( R08-A-024) AND OAK DOWNS DRIVE (R08-A-052). WARD 8, DISTRICT 6.

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the parish; and

WHEREAS, St. Tammany Parish has experienced an increase in traffic at the intersection of Pine Street Extension and Oak Downs Road; and

WHEREAS, affected citizens have requested measures be taken to address this traffic control issue on a parish road; and

WHEREAS, pursuant to the request, Ordinance C.S. No. 08-1829 was adopted by this governing authority to establish a stop intersection at said roadways; and

WHEREAS, after further review by the Parish Engineering Department, it has been recommended that additional traffic studies be conducted at this intersection prior to any signage being placed.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: Ordinance C.S. No. 08-1829, adopted June 5, 2008, establishing a stop intersection on Pine Street Extension (0R08-A-024) and Oak Downs Drive (R08-A-052), Ward 8, District 6, is hereby rescinded and declared repealed.

SECTION II: The Parish Department of Public Works is directed to postpone placement of any additional traffic control signage at these locations until further notified.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION IV: This ordinance shall become effective immediately upon final adoption.
