ORDINANCE TO RENAME E. FAIRWAY DRIVE EXTENSION AS
JUDGE TANNER BOULEVARD

WHEREAS, the proposed E. Fairway Drive Extension, which is currently unopened, extends from Westwood Drive to La. Hwy. 1088;

WHEREAS, the late Judge Thomas Wesley Tanner, retired as Chief Judge of the Twenty-Second Judicial District Court for the Parish of St. Tammany, State of Louisiana, and thereafter served, by appointment of the Louisiana Supreme Court, as Ad Hoc Judge of the 18th, 21st and 22nd Judicial District Courts and the First Circuit Court of Appeals. Judge Tanner was a U.S. Army Veteran, 82nd Airborne, past president of the Louisiana District Judges Association, former Chairman and Vice Chairman of the Law Enforcement Commission, and first President of the Slidell Chamber of Commerce; and

WHEREAS, in honor of Judge Tanner's distinguished service to the residents of St. Tammany Parish.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS

SECTION I. To rename E. Fairway Drive Extension, from Westwood Drive to La. Hwy. 1088, as Judge Tanner Boulevard.

SECTION II. The Department of Public Works is directed, upon the opening of the road, to obtain and place the appropriate street signs to so designate the road as indicated above.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
