ORDINANCE ESTABLISHING A "NO PARKING" ZONE FOR BOTH SIDES OF A PORTION OF HARD HAT DRIVE WARD 3, DISTRICT 2

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO PARKING" zone is hereby established on a portion of Hard Hat Drive (3-H-15), specifically, on both sides of a portion of Hard Hat Drive , beginning at the Oil Row - Hard Hat Drive intersection and proceeding 388' towards Machinist Row.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at this location, in accordance with the attached Engineering data.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective immediately upon final adoption.

The Department of Engineering recommends the installation of "No Parking" signs on Hard Hat Dr.

As per MUTCD, when signs with arrows are used to indicate the restricted parking zones, the signs with the arrows should be set at an angle of not less than 30 degrees and not more than 45 degrees with the line of traffic flow in order to be visible to approaching traffic. **Please set the signs, with the arrows only, to an angle of not less than 30 degrees and not more than 45 degrees with the line of the traffic flow.**

1. Install: "No Parking" sign on the east side of the Oil Row-Hard Hat intersection, 15' from the Oil Row and Hard Hat Dr. Intersection.
2. Install: "No Parking" sign on the North side of Hard Hat Dr., directly across from Job #1.
3. Install: "No Parking" sign on the North side of Hard Hat Dr., right next to mail box 17639.
4. Install: "No Parking" sign on the South side of Hard Hat Dr., directly across from Job #3.
5. Install: "No Parking" sign on the South side of Hard Hat Dr., 25' west of the Hard Hat-Machinist intersection.
6. Install: "No Parking" sign on the North side of Hard Hat Dr., directly across from Job #5.
