ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY TO ACCEPT THE DEDICATION OF THE STREETS, RIGHTS OF WAY AND DRAINAGE SERVITUDES SITUATED WITHIN THE TIMBERLANE SUBDIVISION PHASES 1 AND 2. (WARD 1, DISTRICT 1)

WHEREAS, it was always the intention of the owner/developer of Timberlane Subdivision, Phases 1 and 2, that the streets, rights-of-way, drainage servitudes and detention pond within the subdivision would be public; and

WHEREAS, at the time the final subdivision plats for Timberlane Subdivision Phases 1 and 2 were approved by the St. Tammany Parish Planning Commission, the public dedication language was erroneously omitted from the final subdivision plats; and

WHEREAS, at the present time, the streets, rights-of-way and drainage servitudes are vested in the Timberlane Home Owner's Association, Inc. (the "Association"). The homeowners and the Association desire that the final plat be corrected and the streets, rights-of-way and drainage servitudes within the subdivision be public. The Association is governed by its Board of Directors and the Board of Directors have met and approved the transfer of the ownership of the streets, rights-of-way and drainage servitudes to the Parish of St. Tammany; and

WHEREAS, the matter is to be reviewed by the St. Tammany Parish Planning Commission and an act of correction of the final plat is to be executed by Mr. Kelly J. McHugh, wherein it will be noted that the streets, rights-of-way and drainage servitudes within Timberlane Subdivision were intended to be and are now public; and

WHEREAS, the Department of Engineering has verified that the streets and drainage infrastructure have been constructed to Parish standards.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, in regular session convened that:

SECTION 1. The Office of the Parish President is authorized to execute, on behalf of St. Tammany Parish, any and all documents necessary to accept a dedication of the following streets and rights-of-way within Phase 1 of Timberlane Subdivision: Timberwood Drive, Shadywood Lane and Timberwood Court, all as more particularly depicted on the attached copy of recorded plat File No. 3551, filed September 10, 2004 (Exhibit "A").

SECTION 2. The Office of the Parish President is authorized to execute, on behalf of St. Tammany Parish, any and all documents necessary to accept a dedication of the detention pond, drainage servitudes and the following streets and rights-of-way within Phase 2 of Timberlane Subdivision: Timberwood Loop, Drake Elm Court, Greentree Lane, and Timberwood Drive, all as more particularly depicted on the attached copy of recorded plat File No. 4026, filed September 15, 2005 (Exhibit "B"). The drainage servitudes and detention pond to be dedicated, which are depicted on Exhibit B, are also more particularly depicted on the "as built drawing" in the Department of Engineering, a copy of which is attached hereto as Exhibit "C".

SECTION 3. Upon execution of the aforesaid dedication and transfer of the streets, rights-of-way, drainage servitudes and detention pond, said streets, right-of-ways, drainage servitudes and detention pond shall be included in the St. Tammany Parish maintenance system.

SECTION 4. The St. Tammany Parish Selective Road Maintenance System Inventory is amended to include the streets and rights-of-way set forth in Sections 1 and 2 herein above.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

DATE OF ENACTMENT: This ordinance shall become effective immediately upon final adoption.

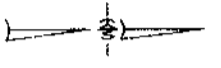

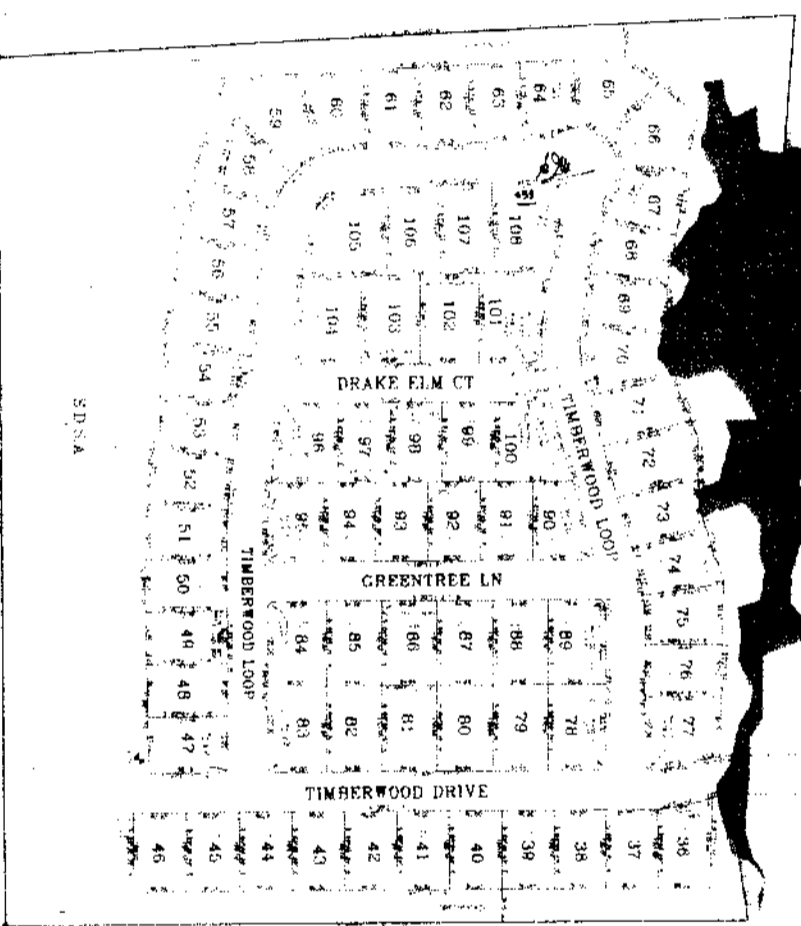

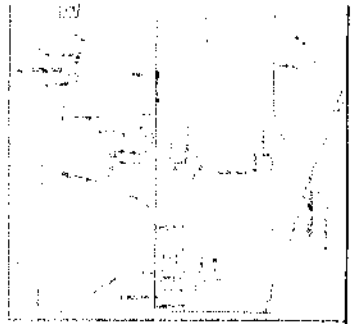

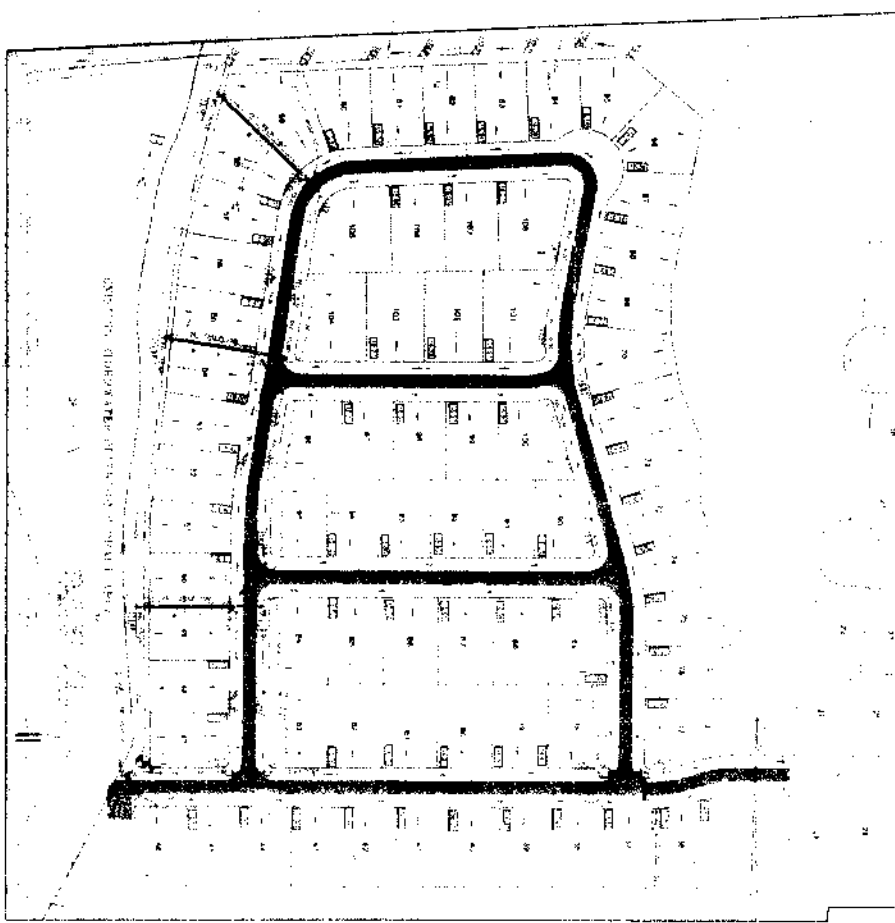
