ORDINANCE TO AMEND ST. TAMMANY PARISH CODE, APPENDIX B, LAND USE REGULATIONS, ORDINANCE NO. 523, SECTION 5.0316, TO PROVIDE FOR A CHANGE IN THE COMMERCIAL SIGNAGE REGULATIONS. (ZC07-11-068)

WHEREAS, the St. Tammany Parish Council has determined that it is necessary to amend those provisions to provide for clarification in the intent of said signage regulations;

WHEREAS, the St. Tammany Parish Council has determined that it is in the best interest of the businesses and citizens of St. Tammany Parish to provide such clarification;

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that the St. Tammany Parish Land Use Regulatory Ordinance No. 523, specifically, Section 5.0303F Standards applicable to non residential uses be amended as follow:

The following standards are applicable to all signs erected or displayed for commercial, industrial and institutional uses and for all other uses except residential uses:

F. Changeable Message Sign Limitation - Movie theater signs are allowed changeable message signs without limitation. All other changeable message signs shall be incorporated into a sign face, but the changeable component must occupy less than one-half the total area of the sign face.

1. If changeable copy is used, it shall be located adjacent to or integrated into the sign face.
- ~~2. Lettering of changeable message signs shall be of a single style and shall be of uniform color and size.~~
- ~~2. 3.~~ Internal illumination, if any, shall be negative contrast.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
