ORDINANCE ACCEPTING FINALIZED SUBDIVISIONS INTO THE ROAD & DRAINAGE INVENTORIES, SPECIFICALLY CASTINE OAKS, PHASE 1; PENN MILL LAKES, PHASE 2A-3; RIVER OAKS, PHASE 10-A; TIMBERLANE, PHASE 1; AND TIMBERLANE, PHASE 2 SUBDIVISIONS; ALSO ACCEPTING STIRLING BOULEVARD; AND ENTERING THE RIGHT OF WAY ON AGNES, NELSON, MOLITOR & SOULT STREETS. THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: All of the area within right-of-way, the road base, surface, drainage ditches, culverts, laterals, canals, and appurtenances thereunto belonging to or otherwise appertaining to the below indicated developments and authorized in the Resolutions stated shall be incorporated into the Parish Selective Maintenance System.
