5. Detention pond slopes are eroding and need to be dressed with a mature stand of grass before warranty can be released;
6. Outfall structure need to be constructed;
7. As-Built drawing needs to be revised after all construction is completed. Show AS-BUILT Top of Bank to confirm full extent of pond.
8. Side walks need to be constructed at greenspaces;
9. Roadways need to be boomed before final acceptance.
10. Outfall structure for East Pond does not conform to the Broad Crested Weir as approved. Need revised hydro to support construction of substitute outfall structure.

4. Silt abatement measures are not functioning. Best Management Practices need to be employed to prevent siltation. It will be necessary that your engineer furnish a silt abatement plan for review by our Watershed Coordinator.
