ORDINANCE AUTHORIZING THE PARISH PRESIDENT TO EXECUTE AMENDED COOPERATIVE ENDEAVOR AGREEMENT AND ACT OF EXCHANGE OF REAL PROPERTY BY AND BETWEEN THE PARISH OF ST. TAMMANY, THE TOWN OF MADISONVILLE AND THE ST. TAMMANY PARISH PUBLIC LIBRARY (WARD 1, DISTRICT 1).

WHEREAS, on April 3, 2008 the St. Tammany Parish Council adopted Ordinance Calendar No. 3772, Ordinance C.S. No. 08-1792, authorizing the Parish President to execute, on behalf of St. Tammany Parish, the attached Cooperative Endeavor Agreement and Act of Exchange by and between St. Tammany Parish, the Town of Madisonville and the St. Tammany Parish Public Library. The Agreement was attached as Exhibit "A"; and

WHEREAS, due to information received following the adoption of said agreement, and at the request of the Town of Madisonville, it is necessary to amend the agreement to include a provision addressing any FEMA funds that may be approved as a result of the damage sustained to the existing Madisonville library building as a result of Hurricane Katrina, and to provide for other matters set forth therein; and

WHEREAS, for all the reasons previously set forth in Ordinance C.S. No. 08-1792, it continues to be in the best interest of the residents of St. Tammany Parish, the Town of Madisonville and the surrounding area that the existing Madisonville Library Branch be replaced.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, in regular session convened that the Parish President is authorized to execute the attached amended Cooperative Endeavor Agreement and Act of Exchange by and between St. Tammany Parish, the Town of Madisonville and the St. Tammany Parish Public Library (See Exhibit "A"); and

BE IT FURTHER ORDAINED that, should it become necessary to provide any further amendments to the Cooperative Endeavor Agreement and Act of Exchange, in order to effectuate the exchange and cooperative endeavor, the Parish President is authorized to negotiate, agree to and execute such amended Agreement, and any and all other documents that may be necessary in furtherance of the agreement contemplated herein.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

DATE OF ENACTMENT: This ordinance shall become effective immediately upon final adoption.
