ORDINANCE ESTABLISHING A "NO PARKING" ZONE ON BOTH SIDES OF A PORTION OF MARINA DRIVE FROM THE MARINA DRIVE/HARBOR DRIVE INTERSECTION (WARD 9, DISTRICT 13)

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO PARKING" zone is hereby established on both sides of a portion of Marina Drive (9-J-130), specifically, beginning 25' from the intersection of Marina Drive and Harbor Drive and proceeding to the end point 323' from the intersection of Marina Drive and Harbor Drive, as per the attached drawing.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at this location, in accordance with the attached Engineering data.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

DATE OF ENACTMENT: This ordinance shall become effective immediately upon final adoption.

9-"NO PARKING" signs (R8-3)

The Department of Engineering recommends the installation of signage on Marina Dr.

1. Install (2) "NO PARKING" signs on each side of the Marina Dr., 25' from the Marina-Harbor intersection facing east.
2. Install (2) "NO PARKING" signs on each side of the Marina Dr., 225' from the Marina-Harbor intersection facing east just past mailbox 878.
3. Install (2) "NO PARKING" signs on each side of the road, 323' from the Marina-Harbor intersection facing east just past mailbox 928B
4. Install "NO PARKING" sign on Marina Dr. 25' south of mailbox 205 facing northward.
5. Install "NO PARKING" sign on Marina Dr., across from existing SL 25 sign facing northward.
6. Install "NO PARKING" sign on Marina Dr. facing northward, 50' from sharp curve on Marina Dr.

Please install signs in accordance with MUTCD standards and see the attached sketch.

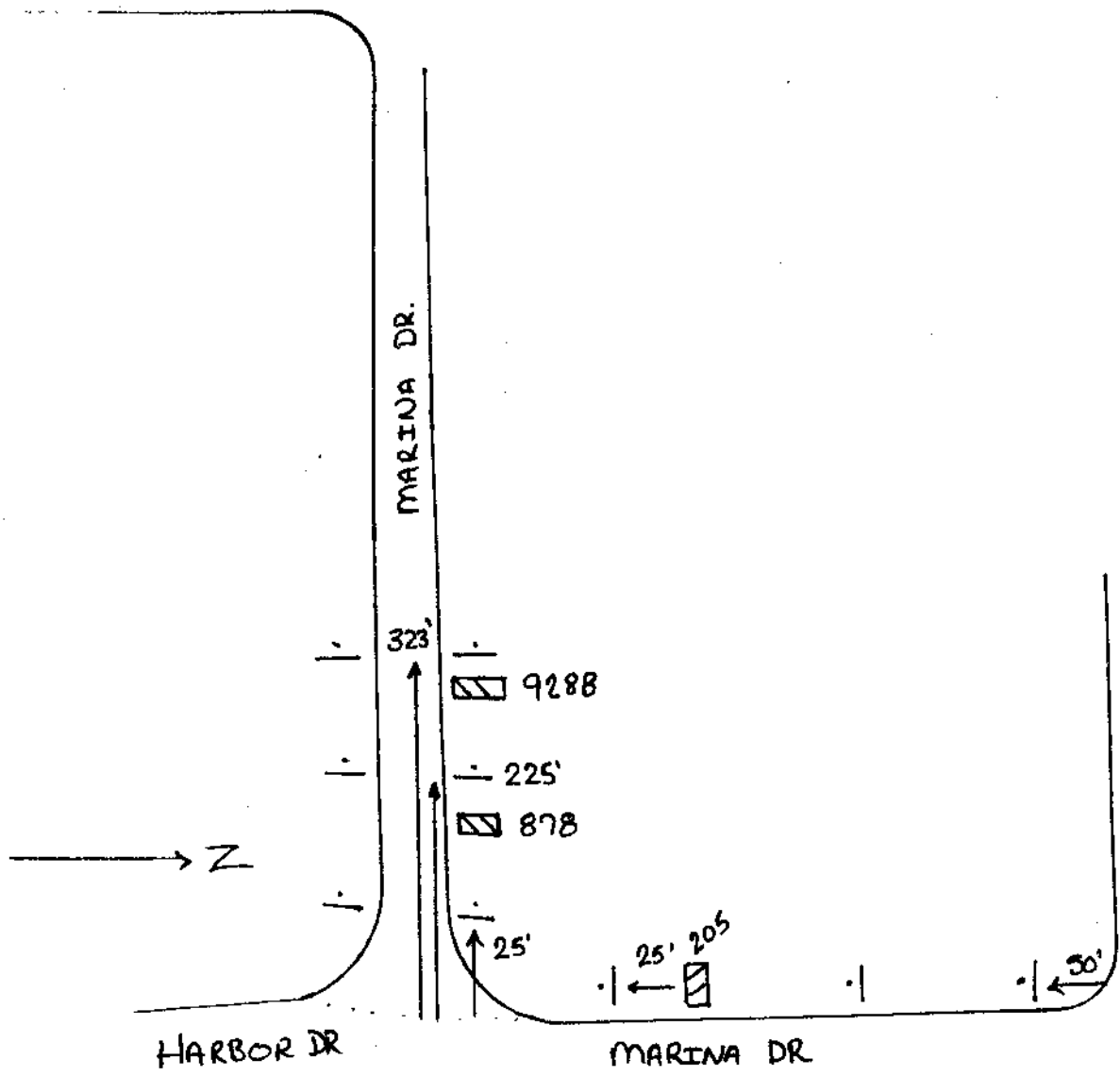
