**AN ORDINANCE TO AMEND ORDINANCE C.S. NO. 06-1415 - 2007-2011 CAPITAL IMPROVEMENTS BUDGET AND PROGRAM; AND TO FURTHER IDENTIFY FIXED ASSET AND GRANT AWARDS**

WHEREAS, the Parish has prepared a capital improvement budget and program in accordance with the Home Rule Charter;
