ORDINANCE CALENDAR NUMBER: 3782

That certain portion of ground, together with all the buildings and improvements thereon, and all the rights, ways, privileges, servitudes, appurtenances and advantages thereunto belonging or anywise appertaining, situated in the Parish of St. Tammany, State of Louisiana, being a part of fractional Square 2801 of the Division of New Covington Addition, more fully described as forming the corner of Madison Street and West 28<sup>th</sup> Avenue, having a front of 118.24 feet (Title 119.45 feet) on Madison Street by a depth of 148.81 feet on West 28<sup>th</sup> Avenue (Title 147.94 feet); 120.86 feet (Title 120.89 feet) on the rear line extending from West 28<sup>th</sup> Avenue in the direction of North Columbia Street; and 149.14 feet (Title 149.09 feet) on a line parallel to West 28<sup>th</sup> Avenue and closing on Madison Street. Said property is more fully described and shown on a survey of Berlin Land Survey, dated 9/4/86 and revised 12/4/86.

That certain portion of ground, together with all the buildings and improvements thereon, and all the rights, ways, privileges, servitudes, appurtenances and advantages thereunto belonging or anywise appertaining, situated in the Parish of St. Tammany, State of Louisiana, being Lot 8 and a part of Lot 7, Square 2701, New Covington, Town of Covington, St. Tammany Parish, Louisiana. Lot 8 measures 60 feet front on 28<sup>th</sup> Avenue by a depth of 140 feet between equal and parallel lines and 13 feet of Lot 7 as it adjoins Lot 8 fronting on 28<sup>th</sup> Avenue by a depth of 79.6 feet between equal and parallel lines; said total property fronts by 73 feet on 28<sup>th</sup> Avenue.

That certain portion of ground, together with all the buildings and improvements thereon, and all the rights, ways, privileges, servitudes, appurtenances and advantages thereunto belonging or anywise appertaining, situated in the Parish of St. Tammany, State of Louisiana, situated in the City of Covington in that portion known as the Division of New Covington, Covington, St. Tammany Parish, State of Louisiana, said property being more fully described as Square 2602, Lots 4 & 5, Division of New Covington, Covington, St. Tammany Parish, Louisiana, Said Lots 4 & 5 are bounded by 26<sup>th</sup> Avenue and Madison Street.
