ORDINANCE TO APPROVE AND AUTHORIZE ST. TAMMANY PARISH THROUGH THE OFFICE OF THE PARISH PRESIDENT TO SIGN AND/OR EXECUTE DEVELOPMENTAL AGREEMENT BETWEEN THE PARISH OF ST. TAMMANY AND MAURMONT PROPERTIES, L.L.C.

WHEREAS, LA R.S. 33:4780.21 through 33:4780.33 authorizes the Parish of St. Tammany to enter into Developmental Agreements with developers of land; and to provide for the contents, periodic review, enforcement and applicability of said agreements; for amendment, cancellation, modification and/or suspension; and

WHEREAS, the lack of certainty in developments can result in a waste of resources, escalate the cost of development to the consumer, and discourage investment and commitment to comprehensive planning; and

WHEREAS, it is the intent of the Parish to enter into a Developmental Agreement which may specify the duration of the agreement, the general uses of the property, the density and intensity of use and any other such provisions deemed appropriate by the Parties; and

WHEREAS, St. Tammany Parish Council enacted Ordinance No. CS No. 04-0990 known as the "St. Tammany Parish Transportation Impact Fee Ordinance" and, the "St. Tammany Parish Drainage Impact Fee Ordinance" which provides for the credit and collection of impact fees to compensate for the impact of development upon transportation and drainage infrastructure arising from development and construction within St. Tammany Parish more fully set forth in the Impact Fee Ordinance;

WHEREAS, Maurmont and the Parish desire that certain improvements to public property be made in and around property owned by Maurmont located south of Interstate 12 and east of Louisiana Highway 21 in St. Tammany Parish; to facilitate the improvements, Maurmont and the Parish have agreed to execute a Developmental Agreement in consideration of land donated for road rights of way and improvements to be made by Maurmont upon public property, and a contribution by Maurmont to the cost of construction.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Parish President is hereby authorized to sign and/ or execute a Developmental Agreement between St. Tammany Parish and Maurmont Properties, L.L.C. and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions authorized herein; and

BE IT FURTHER ORDAINED that the Developmental Agreement shall be recorded in the records of the clerk of Court of St. Tammany Parish, if applicable, and this Ordinance shall serve as an attachment thereto; and

THAT all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

EFFECTIVE DATE: This ordinance shall become effective immediately after adoption.
