ORDINANCE AUTHORIZING THE PARISH PRESIDENT TO EXECUTE COOPERATIVE ENDEAVOR AGREEMENT BY AND BETWEEN ST. TAMMANY PARISH, GRAVITY DRAINAGE DISTRICT NO. 5 AND SUB DRAINAGE DISTRICT NO. 2 FOR THE PURPOSE OF PROVIDING DRAINAGE IMPROVEMENTS TO THE COMMON DRAINAGE INFRASTRUCTURE BETWEEN MEADOWBROOK AND ROSEDOWN SUBDIVISIONS (Ward 4 District 5).

WHEREAS, in order to provide for the needed improvements to the common drainage infrastructure between the Meadowbrook and Rosedown Subdivisions, which is anticipated to improve the drainage in those subdivisions and the surrounding areas, thereby addressing the current adverse drainage impacts in said areas, it is necessary to establish a Cooperative Endeavor Agreement by and between St. Tammany Parish, Gravity Drainage District No. 5 and Sub-Drainage District No. 2 of Gravity Drainage District No. 5; and

WHEREAS, it is in the best interest of the public health, safety and welfare to provide the needed improvements to the common drainage infrastructure between the Meadowbrook and Rosedown Subdivisions, which are not expected to cost more than fifty thousand (\$50,000.00) dollars.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that Parish President is authorized to execute a Cooperative Endeavor Agreement by and Between St. Tammany Parish, Gravity Drainage District No. 5 and Sub-Drainage District No. 2 of Gravity Drainage District No. 5, and any and all documents necessary to effectuate that agreement, for the purpose of providing drainage improvements to the common drainage infrastructure between the Meadowbrook and Rosedown Subdivisions at a cost not to exceed fifty thousand (\$50,000.00) dollars.

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinances are hereby declared to be severable.

DATE OF ENACTMENT: This Ordinance shall become effective fifteen (15) days after adoption.
