ORDINANCE TO AMEND APPENDIX B OF THE ST. TAMMANY PARISH CODE OF ORDINANCES. SUBDIVISION REGULATORY ORDINANCE NO. 499; SPECIFICALLY, SECTIONS 40-045.0, 2B.5., 40-060.0, 2G., 40-061.0, 3., 40-070.0, AND 40-80.0.1A.II, 5., AND 1B., 2E. TO REPLACE REFERENCES TO THE "PARISH ENGINEER" WHERE DEPICTED AND APPROPRIATE, WITH "DIRECTOR OF THE DEPARTMENT OF ENGINEERING".

WHEREAS, pursuant to instruction by the parish administration, the purpose of this amendment shall provide clear definition as to whom from the department of engineering will be able to sign subdivision plats and other various documents on behalf of said department.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that Sections 40-045.0 2B.5., 40-060.0, 2G., 40-061.0, 3., 40-070.0 and 40-80.0.1A.II, 5., and 1B., 2E. be hereby amended by replacing references to the "Parish Engineer", where depicted and appropriate within said sections, with the "Director of the Department of Engineering".

REPEAL: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
