RESOLUTION PROVIDING FOR CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE SPECIAL ELECTION HELD IN THE PARISH OF ST. TAMMANY, STATE OF LOUISIANA, ON SATURDAY, OCTOBER 4, 2008, TO AUTHORIZE THE RENEWAL OF SPECIAL TAXES THEREIN

BE IT RESOLVED by the Parish Council of the Parish of St. Tammany, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of St. Tammany, State of Louisiana, that:

SECTION 1. Canvass. This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special election held in the Parish of St. Tammany, State of Louisiana, on SATURDAY, OCTOBER 4, 2008, to authorize the renewal of special taxes therein, and said Governing Authority does further proceed to examine and canvass the returns and declare the results of the special election.

SECTION 2. Procès Verbal. A *Procès Verbal* of the canvass of the returns of said election shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; another certified copy thereof shall be forwarded to the Clerk of Court and *Ex-Officio* Recorder of Mortgages in and for the Parish of St. Tammany, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.

SECTION 3. Promulgation of Election Results. The results of said election shall be promulgated by publication in the manner provided by law.

BE IT KNOWN AND REMEMBERED that on Thursday, November 6, 2008, at six o'clock (6:00) p.m., at its regular meeting place, the Council Chambers of the Parish Government Complex, 21490 Koop Drive, Mandeville, Louisiana, the Parish Council of the Parish of St. Tammany, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of St. Tammany, State of Louisiana (the "Parish"), and being the authority ordering the special election held therein on Saturday, October 4, 2008, with the following members present:

did, in open and public session, examine the official certified tabulations of votes cast at the said election, and did examine and canvass the returns of the said election, there having been submitted at said election the following propositions, to wit:

PROPOSITION NO. 1  
(TAX RENEWAL)

SUMMARY: 10 YEAR 1 MILL PROPERTY RENEWAL TAX FOR ACQUIRING, CONSTRUCTING, IMPROVING, MAINTAINING AND OPERATING AN ANIMAL SHELTER FOR THE PARISH, INCLUDING NECESSARY EQUIPMENT AND FACILITIES THEREFOR.

Shall the Parish of St. Tammany, State of Louisiana (the "Parish"), levy a one (1) mill tax on all the property subject to taxation in the Parish (an estimated \$1,092,700 reasonably expected at this time to be collected from the levy of the Tax for an entire year) for a period of ten (10) years, beginning with the year 2009 and ending with the year 2018, for the purpose of acquiring, constructing, improving, maintaining and operating an animal shelter for the Parish, including necessary equipment and facilities therefor?

PROPOSITION NO. 2  
(TAX RENEWAL)

SUMMARY: 10 YEAR 2 MILLS PROPERTY TAX RENEWAL FOR PROGRAMS OF SOCIAL WELFARE TO BE DEDICATED (1) 50% FOR ACQUIRING, CONSTRUCTING, IMPROVING, MAINTAINING AND OPERATING AUTHORIZED ACTIVITIES, SERVICES, PROGRAMS AND/OR FACILITIES OF AND FOR THE ST. TAMMANY PARISH COUNCIL ON AGING AND (2) 50% FOR ACQUIRING, CONSTRUCTING, IMPROVING, MAINTAINING AND OPERATING AUTHORIZED ACTIVITIES, SERVICES, PROGRAMS AND/OR FACILITIES FOR INDIVIDUALS WITH MENTAL RETARDATION AND/OR DISABLED PERSONS IN THE PARISH.

Shall the Parish of St. Tammany, State of Louisiana (the "Parish"), levy a two (2) mills tax on all the property subject to taxation in the Parish (an estimated \$2,185,400 reasonably expected at this time to be collected from the levy of the Tax for an entire year) for a period of ten (10) years, beginning with the year 2009 and ending with the year 2018, for programs of social welfare with the avails to be dedicated as follows:

- (i) 50% for the purpose of providing funds for acquiring, constructing, improving, maintaining and operating authorized activities, services, programs and/or facilities of and for the St. Tammany Parish Council on Aging, and
- (ii) 50% for the purpose of providing funds for acquiring, constructing, improving, maintaining and operating authorized activities, services, programs and/or facilities for individuals with mental retardation and/or disabled persons in the Parish?
