AN ORDINANCE ESTABLISHING A "NO THRU TRUCKS" ZONE ON LONESOME ROAD (4-D-32) WARD 4, DISTRICT 10.

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the Parish; and

WHEREAS, St. Tammany Parish has experienced an increase in truck traffic, proceeding at unsafe speeds through the primarily residential neighborhood of Lonesome Road; and

WHEREAS, the affected citizens have requested a no thru truck zone to remedy the situation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO THRU TRUCKS" ZONE is hereby established on Lonesome Road (4-D-32), as indicated on the attached traffic plan by the Department of Engineering. WARD 4, DISTRICT 10.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at these locations.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION IV: This ordinance shall become effective fifteen (15) days after adoption.
