# A RESOLUTION REESTABLISHING THE LEGAL MAXIMUM MILLAGE RATES FOR THE YEAR 2008

#### **RESOLUTION NO. 2**

NOW, THEREFORE, BE IT RESOLVED BY THE ST. TAMMANY PARISH COUNCIL, in a public hearing held on August 7, 2008, which hearing was conducted in accordance with the open meetings law and the additional requirements of Article VII, Section 23(C) of the Constitution, that the taxing authority voted to increase the millage rate(s), but not in excess of the prior year's maximum rate(s), on all taxable property shown on the official assessment roll of the year 2008, and when collected, the revenues from said taxes shall be used only for the specific purposes for which the said taxes have been levied.
