ORDINANCE ESTABLISHING A "NO PARKING" ZONE ON BOTH
SIDES OF WEBSTER STREET (4-D-51) (WARD 4, DISTRICT 10)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the parish; and

WHEREAS, St. Tammany Parish has experienced an increase in parking along portions of Defiance Drive, particularly at the intersections of side streets; and

WHEREAS, affected citizens have requested control measures be taken to address this unsafe situation on Parish roads.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO PARKING" zone is hereby established on both sides of Webster Street beginning at Lafitte Street and continuing to Carroll Street.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at this location, in accordance with the attached Engineering data.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

DATE OF ENACTMENT: This ordinance shall become effective immediately upon final adoption.

6-"NO PARKING On Pavement" signs (R8-1)

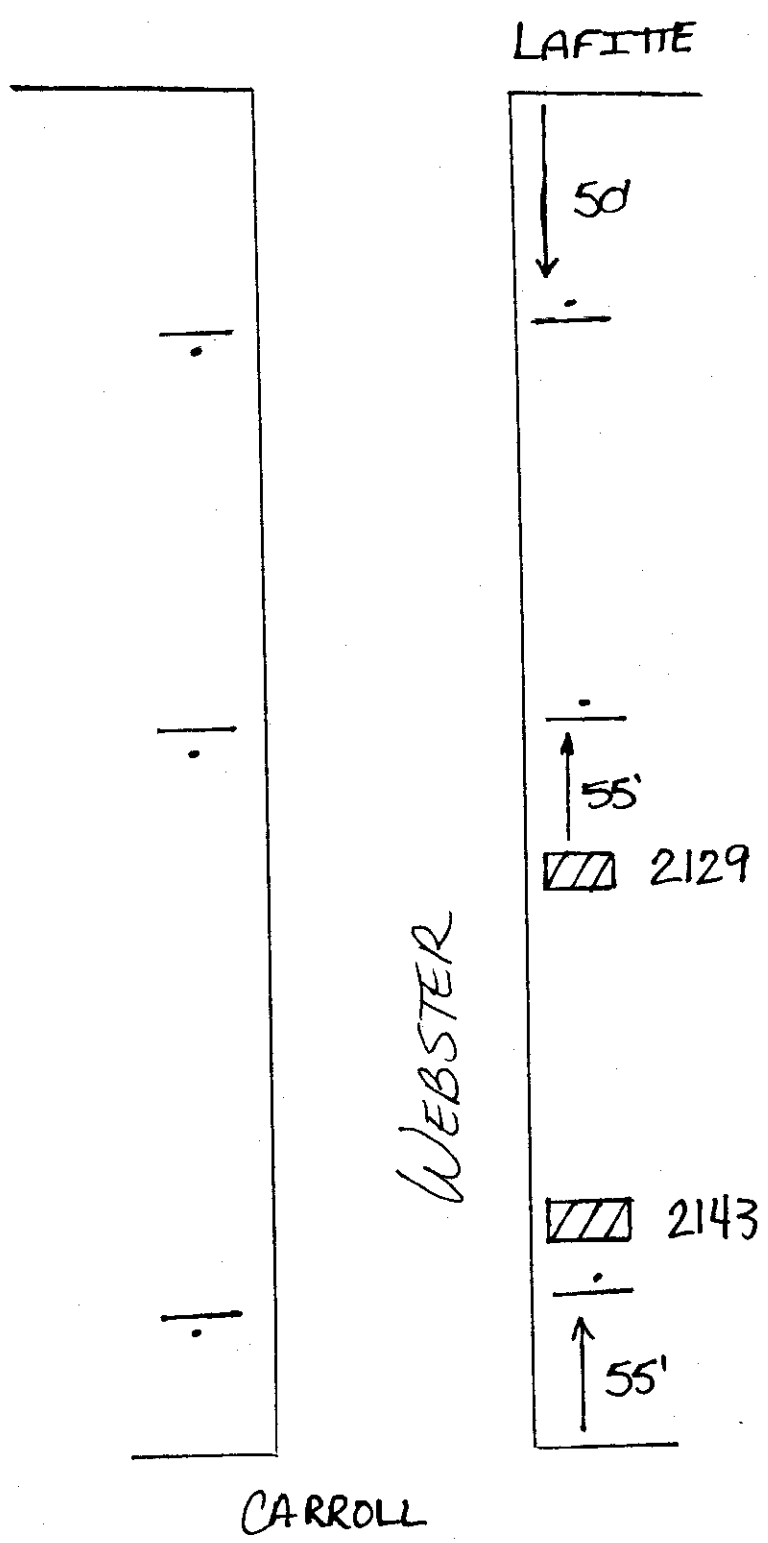
The Department of Engineering recommends the installation of signage on Webster St.

1. Install (2) "NO PARKING" signs on each side of Webster, 50' from the Webster and Lafitte intersection.
2. Install (2) "NO PARKING" signs on each side of Webster, 55' from mailbox 2129 on property line.
3. Install (2) "NO PARKING" signs on each side of Webster, 55' from the Webster and Carroll intersection.
