AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE TCHEFUNCTE STREET; TO INCLUDE EXTENSIONS OF VINCENT STREET, BONFOUCA STREET, W. HIGGINS ROAD, SCOTCH PINE DRIVE, AND TO REMOVE A PORTION OF E.T. ROAD. WARDS 2, 4, 5 & 9, DISTRICTS 2, 4 & 6
THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that
<u>SECTION 1:</u> The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:
<ol> <li>Add Tchefuncte Street, located off Jefferson Street, Ward 9, District 6;</li> <li>Add an approximate 204' extension to Vincent Street (R09D058), Ward 9, District 6;</li> <li>Add an approximate 260' extension to Bonfouca Street (R09D034), Ward 9, District 6;</li> <li>Add an approximate 375' extension to W. Higgins Road (R05A032), Ward 5, District 2;</li> <li>Add an approximate 910' extension to Scotch Pine Drive (R04C021), Ward 4, District 4; and</li> <li>Remove approximately 350 feet from the length of E.T. Road (R02P040), corrected length is 300 feet, Ward 2, District 2.</li> </ol>
SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.
SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.
SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.
SECTION V: This ordinance shall become effective fifteen (15) days after adoption.
