ORDINANCE ESTABLISHING A "NO PARKING" ZONE ON BOTH SIDES OF POWELL DRIVE (9-D-40) FROM HWY 11 TO POWELL ROAD (WARD 9, DISTRICT 14)

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: A "NO PARKING" zone is hereby established on both sides of Powell Drive beginning on the west side of Powell Drive 100 feet north of Hwy 11 and the Powell Drive intersection and extending to 190 feet north of mailbox 60347 and on the east side of Powell Drive beginning 190 feet north of mailbox 60347 and extending to 60 feet south of mailbox 60347.

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at this location, in accordance with the attached Engineering data.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

DATE OF ENACTMENT: This ordinance shall become effective immediately upon final adoption.

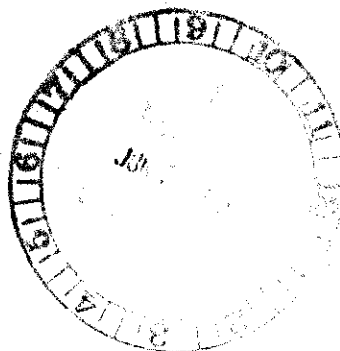

The Department of Engineering recommends the installation of signage in District 14.

As per MUTCD, when signs with arrows are used to indicate the restricted parking zones, the signs with the arrows should be set at an angle of not less than 30 degrees and not more than 45 degrees with the line of traffic flow in order to be visible to approaching traffic.

- 1.) Install (2) "NO PARKING" signs on each side of Powell Dr. 190' north of mailbox 60347.
- 2.) Install (2) "NO PARKING" signs on each side of Powell Dr. 60' south of mailbox 60347.
- 3.) Install "NO PARKING" sign on Powell Dr. 225' north of the Hwy 11 and Powell Dr. intersection.
- 4.) Install "NO PARKING" sign on Powell Dr. 100' north of the Hwy 11 and Powell Dr. intersection.
