ORDINANCE AUTHORIZING THE PARISH PRESIDENT AND COUNCIL CHAIRMAN TO ENTER INTO NEGOTIATIONS WITH ONE OR MORE QUALIFIED PROPOSERS AND TO EXECUTE A CONTRACT OR CONTRACTS WITH THE QUALIFIED PROPOSER(S) TO THE ST. TAMMANY PARISH REQUEST FOR PROPOSAL #450-13-08-03-3 FOR TRANSIT SERVICE DATED JULY 10, 2008.

WHEREAS, St. Tammany Parish has or will receive grant funds to implement parish wide transit services: and

WHEREAS, in order to identify the most qualified individuals to provide the transit service St. Tammany Parish issued a Request for Proposal #450-13-08-03-3 dated July 10, 2008 requesting proposals for the implementation and operation of a transit service, particularly, municipal circulators in the three major municipalities, intra-parish commuter service, regional commuter service and possible rural service; and

WHEREAS, when the most qualified proposer or proposers are identified the Parish will then enter into contracts with the proposers to provide the transit services stated above; and

WHEREAS, it is in the best interest of the general health and welfare of the citizens of St. Tammany Parish to enter into contract(s) for the operation and implementation of Transit Services.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that the Parish Council approves and authorizes the Parish President and Council Chairman to jointly enter negotiations with the most qualified proposers to the Request for Proposal #450-13-08-3 for Transit Service.

BE IT FURTHER ORDAINED that the Parish Council approves and authorizes the Parish President and Council Chairman to jointly execute one or more contracts with the most qualified proposers to the Request for Proposal #450-13-08-3 for Transit Service.
