ORDINANCE CORRECTING THE BOUNDARY DESCRIPTION OF SEWAGE DISTRICT NO. 6 OF THE PARISH OF ST. TAMMANY, ARTICLE II SEWAGE DISTRICTS, DIVISION 7 DISTRICT NO. 6, SECTION 21-076.00 OF THE ST. TAMMANY PARISH CODE OF ORDINANCES (Ward 3, District 3).

WHEREAS, Ordinance P.J.S. No. 901, adopted December 21, 1978, changed the boundaries of Sewage District No. 6, which boundaries were expressly described as set forth therein, and expressly provided that "said boundaries to *remain* outside the corporate limits of any municipality;" and

WHEREAS, during the process of mapping the boundaries, it was recently discovered that an error in the described boundaries unintentionally extended a small part of Sewage District No. 6 into the corporate limits of the City of Covington; and

WHEREAS, in order to comply with the requirement that the boundaries of Sewage District No. 6 remain outside the corporate limits of any municipality (per Ord. P.J.S. No. 901), it is necessary to correct the boundary description error.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that the boundary description of Sewage District No. 6, as set forth in Ordinance P.J.S. No. 901 and as codified in SEC. 21-076.00 of the St. Tammany Parish Code of Ordinances, is hereby corrected and, as corrected herein below, said boundaries are reestablished retroactively to the date of adoption of Ordinance P.J.S. No. 901:

SEC. 21-076.00 Created: Boundaries

A Sewage District is hereby created within the Parish outside the corporate limits of any municipality, which shall comprise and embrace all of that territory within the following described boundaries:

Starting at a point where the south boundary of Township 6, South, Range 11 East intersects the west city limits of the Town of Abita Springs, La.; thence follow the city limits of Abita Springs north and east to the west right-of-way of Highway 59; thence north along said Highway 50 right-of-way to a point 250 feet north of Lowe Davis Road; thence in a southwesterly direction 250 feet north and west parallel to Lowe Davis Road to the intersection of a line 250 feet north and west parallel to Wilkerson St.; thence in a southwestern direction 250 feet north and west parallel to the Wilkerson Street to a point 250 feet north of Highway 36; thence 250 feet north and parallel to Highway 36 to the east right-of-way of Highway 21; thence due west to the Little Bogue Falaya River, thence south along the Bogue Falaya River to the intersection of south right-of-way of Illinois Central Gulf Railroad; thence in an easterly direction along the south right-of-way of the Illinois Central Gulf Railroad to the east right-of-way of La. Highway 21; thence in a southerly direction along the east right-of-way of La. Highway 21 **to the intersection of La. Highway 190 Business; thence continue in a southerly direction along the east right-of-way of La. Highway 190 Business** to the south boundary of Township 6 South, Range 11 East; thence east along the south boundary of Township 6 South, Range 11 East, to the west city limits of the Town of Abita Springs, Louisiana, the point of beginning.
