ORDINANCE TO AMEND ORDINANCE COUNCIL SERIES NO. 08-1838 TO ADJUST THE LENGTH OF THE EXTENSION TO BESSIE BOOTH ROAD BEING ACCEPTED INTO THE MAINTENANCE SYSTEM. WARD 2, DISTRICT 3

WHEREAS, Ordinance Council Series No. 08-1838, adopted June 5, 2008 corrected the road inventory to include/remove certain roads or portions of roads in the Parish road maintenance system, of which Bessie Booth Road was a part of; and

WHEREAS, item # 1 of said Ordinance Council Series No. 08-1838 included an approximate 715' extension to Bessie Booth Road (R02J013). This length is inaccurate, and it has been determined that the proper length of the extension is 310 feet.

WHEREAS, it is the desire of this Council that this error be corrected and that the road extension of Bessie Booth Road be changed from 715 feet to 310 feet within the Parish's road maintenance system; and

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: Ordinance Council Series No. 08-1838, adopted June 5, 2008, is hereby amended to reflect the approximate extension of Bessie Booth Road to be added to the Parish's road inventory is 310 feet, which results in a total length of Bessie Booth Road of 715 feet.

SECTION II: The Parish Department of Public Works is hereby directed to make the appropriate adjustments within the Parish Road Maintenance System, as indicated.

REPEAL: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

ORDINANCE TO CORRECT THE ROAD INVENTORY TO INCLUDE AN EXTENSION OF BESSIE BOOTH ROAD; AN EXTENSION OF DUPARD STREET; AN EXTENSION OF 12TH STREET; ALSO REORGANIZING THE ROAD DATA OF EAST HOWZE BEACH ROAD AND INCLUDING WEST END BOULEVARD INTO THE MAINTENANCE SYSTEM. WARDS 2, 3, 4 & 9. DISTRICTS 1, 3, 10 & 13

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that

SECTION I: The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add an approximate 715' extension to Bessie Booth Road (R02J013), Ward 2, District 3
2. Add an approximate 500' extension to Dupard Street (R04D110), Ward 4, District 10
3. Add an approximate 130' extension to 12th Street (R03A023), Ward 3, District 1
4. Include West End Boulevard (approx. 4,800') located off Oak Harbor Boulevard, Ward 9, District 13
5. Remove approximately 5,559 from the length of East Howze Beach Road (R09J208), corrected length is 11,930. Ward 9, District 13
6. Assign new Road Inventory Number to the remaining portion of East Howze Beach Road, approximate length of 2,700'. Ward 9, District 13.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective fifteen (15) days after adoption.




